MINUTES OF THE ANNUAL MEETING FIRST CONGREGATIONAL CHURCH OF OLD LYME JANUARY 27, 2019

The meeting was called to order by Charlie Hosley, Chair of the Church Council, at 12:15 PM. This was followed by the Invocation, given by Reverend Laura Fitzpatrick-Nager.

Joan May, Church Clerk, made the Call to the Annual Meeting, stating that the purpose of the meeting is as follows:

- To receive the reports of the ministers, boards and committees of the church, and the church officers for 2018
- To approve the budget for the year 2019
- To receive and approve the report of the nominating committee
- To elect officers and board members for the coming year
- To conduct such old and new business as brought before the Congregation.

Joan May acknowledged the presence of a quorum of at least 40 church members.

A motion was made to waive the reading of the minutes from the 2018 Annual Meeting, as the minutes were printed in the Annual Report.

Individual reports were then presented. All those offering reports referred to the printed reports that appear in the 2018 Annual Report.

Steve Jungkeit, Senior Minister Steve opened with a beautiful parable from Dave Egger's book, "The Lifters," - "when things fall down who lifts them up." Steve talked about the book, as we try to discover what it means to be lifters by mending, healing and reconciling as we did for Malik & Zahida, our sanctuary couple. Steve cited the image on the cover of the Annual Report by Roniya, their daughter. We became lifters. And, we did our best in other ways. Steve cited the arrival of Laura Fitzpatrick-Nager, hosting our friends in the South African choir, celebrating Carleen as she transitioned to part-time, welcoming the Kazida's, Israel-Palestine. We've been lifted at the same time through the dinners we've shared, baptisms, weddings, music, community sales, in our prayers. We've done an enormous amount this year in our vocation as lifters. Steve concluded with Isiah 58. "If you offer your food to the hungry ... then your light will rise in the darkness....In other words, you shall be lifters. Thankyou, all of you, for all what you did and continue to do.

<u>Laura Fitzpatrick-Nager, Senior Associate Minister</u>, cited her letter in the Annual Report. She is full of incredible gratitude and joy. She started on March 18, 2018. It's been an extraordinary year, what we've done together. She thanked Steve and Carleen for their shepherding. It's a privilege to be part of their team. And also to walk beside Lisa Doggart and Mary Thomassetti. Laura traveled to Haiti for the first time, which was life changing, as was the trip to Green Grass. She thanked each and every one in the congregation.

<u>Carleen R. Gerber, Associate Minister</u> Carleen expressed appreciation for the church's expression of gratitude last fall at a special coffee hour. She is honored to work with this energetic congregation. Now that she is part-time, her emphasis is on Pastoral Care. She needs everyone's input to know when a congregant needs a visit. Hospitals don't always tell us. She thanked several people in particular.

Church Clerk, Joan May Membership over the past year was stable, with a slight decline from to 803 members over the year. Membership losses are primarily due to changes of status from Active to Inactive initiated by the ministers. The ministers performed 12 baptisms 10 marriage ceremonies. Joanie gives thanks to Joan Kelley, the Clergy, and the office staff for their assistance in maintaining the vital statistics of the Church.

Board of Deacons, Don Gonci for Elizabeth Nocera, Co-Chairs Don read Elizabeth's report saying it was a pleasure to work with Don Gonci. The Deacons were deeply moved to support the ministry of providing Sanctuary and to support immigration work. Grateful for all the work people did. It has been a busy board on duty every Sunday morning, serving communion 5 times a year, organizing ushers, organizing coffee hour. Don mentioned the conclusions of the U.N. Climate Summit and how the trends of global warming can be slowed if we make adjustments. Don has created a working group to look at actions we can take. There continues to be a broad exchange of ideas including with our young people and the Environmental Committee. He mentioned the ringing of steeple bells, being done by many New England congregational churches.

Mary Kate Cox, Board of Stewardship Mary Kate stepped in to finish Mike Long's term as chair. Gave credit to the leadership and passion of Mike Long. Mary Kate started with John Kiker's words from website, recalling the theme of the 2019 Campaign, "Sharing Our Lives, Sharing Our World," which captures the spirit of what we're trying to do — enact a vision of changing ourselves and changing the world. Mary Kate welcomes and appreciates any suggestions if more will find it in their hearts to pledge. Cited this morning's Hymn, "How firm a foundation." We are trying to lay a new foundation. Thanked everyone who has pledged. Thanked outgoing members. Thanked Joanie May for her office support.

<u>Board of Youth Education, Lisa Doggart</u> Lisa presented the report for Shay Cantner, Chair, who thanked all volunteers who worked with Sunday School and on Sunday mornings. There has been a great sense of community, working on Justice and other projects. She praised the enthusiastic Board of Youth Ed group and mentioned some new activities such as Sunday night Soups. Youth and parents have all participated.

<u>Adult Education – David Ogle</u> His primary responsibility is to coordinate Adult Forums. He cited his report. It is not easy to find interesting and relevant speakers. He appreciates everyone's suggestions, and people should feel free to offer them. Recognized members of his committee. Thanked Mark Testori. Thanked Laura and Carleen without whom he could not function.

<u>Board of Missions, Jennifer Hall</u> Missions met 6 times in 2018. They work diligently to distribute funds and have tough decisions to make. Jen encouraged everyone to recommend organizations and to get involved with Mission decisions and church activities. Need everyone's support. Thanked Board members.

Immigrant Assistance Committee presented by Mary Tomassetti She loves this meeting. It's awesome, and is one of the things that attracted her to this church. She loves the book — the Annual Report -- for its overview of everything we do and its transparency. We have recently welcomed the Torres family. She expressed gratitude for all we have done over last year. We don't know what 2019 will bring. Flexibility will be important

<u>Refugee Resettlement Project, Scott Harris</u> Scott cited his report. He's one of the co-chairs with someone from St. Ann's Episcopal Church. He mentioned the hard work of all three churches, including Christ the King, for successfully resettling our refugee families.

South Lyme Chapel, Steve Joncus, Trustee He cited his report. During first part of 2018, leadership by Tom Burke was very impressive. He was very dynamic. He is now in Weston, CT. Tom was followed by Rebecca Francisco, a graduate of Princeton Theological Seminary, who is an expert on biblical history. He mentioned the sad loss Bea Minson, who was 98 years old. Her family has always worked hard at the White Elephant Sale, and they will be back this year.

<u>Ladies' Benevolent Society, Nick Westbrook for Jane Marolda</u> Nick mentioned Jane's son, who is recovering from an accident in November. He cited his report. LBS was formed over 200 years ago as a

forum for women of this church, who at the time were not allowed to speak at meetings. He cited the LBS luncheons, the Ladies who Stitch, and the two successful White Elephant Sales, which brought in \$82,000, half of which goes to support this church. The rest is donated to a long list of other charitable organizations from our local area to South Dakota, Haiti and Palestine. Nick thanked all members of the LBS.

<u>Board of Trustees, David Long</u> He cited his report and the Endowment report. The Board of Trustees has 9 members and 7 committees, 2 of which were new this year: Communications and Preservation committees. He thanked all BOT members. They are responsible for a wide range of issues and responsibilities. He thanked church staff, and ministers.

Treasurer's Report, Bob McCracken, Church Treasurer He presented a brief look at the numbers, citing particular page numbers. On page 17, Revenues and Expenses, Revenues were \$12,000 over budget. Expenses also over budget, ending with a small surplus of \$3,600.00, which will be moved over to the balance sheet for previous year's deficit. Page 18 shows a dramatic difference of where contributions came from. Pledges were lower. However the next 4 lines are all substantially over budget. The congregation was very generous this year. It makes forecasting more complicated, but was good news. Then he explained a few individual accounts. Benevolences - Missions holds back their distributions to see what funds are available. There was an outpouring of generous financial support for immigration and refugee efforts.

Putting on his Administrator's hat — Bob praised the dedication of the administrative staff. Joan Kelley, Mark Testori, Teri Gedrys, Joanie May, Bill Slivinski. They do a lot of work and are very good at it. It is a great group, and they also have a lot of fun. The staff gets along well and like each other. Staff meetings have many moments of levity.

Bob spoke for Jonathan French, Chair of Budget Committee, who had to work today. Bob thanked Jonathan, Leslie Kiem and Jeanne Thomas. The budget is done from bottom up, not top down. The committee asks all boards and committees and ministers to submit their goals. Bob cited pgs. 27 & 28 and described the pie charts. Top one is typical. The bottom one depicts the 6 fundamental missions of church, showing how resources are devoted, which is a more accurate picture of our priorities.

Bob presented the 2019 budget, which forecasts an increase of revenues, which allows for an increase of 2% in compensations. Laura is now full time; Carleen is now half time. The Music budget has 2 more professional voices. Office is slightly lower. A significant upgrade of software is budgeted in order to receive online contributions. There are some website administration costs. Maintenance is budgeted to be significantly higher to catch up from lower expenditure in 2018. Bob recognized the generous \$10,000 increase from LBS. Motion to approve and second. No discussion. All in favor. Motion passed.

Charlie Hosley presented the Nominating Committee report containing the list of officers and Board members. The Nominating Committee and ministerial staff have worked hard. Elizabeth Nocera presented two phenomenal people, Bob and Marilyn Regan as Deacons Emeritii. He presented their history of helping and serving the church. The nominating slate of 2019 Officers, Board Members and Deacon Emeriti was approved, following motion to approve and second. No discussion. All in favor.

Carleen Gerber asked for a vote to approve the minutes of 2018 Annual Meeting. Motion was seconded and approved.

Steve Jungkeit then closed with the benediction reading words from "God of Grace and God of Glory."

The meeting was adjourned at 1:42 pm.

SENIOR MINISTER'S ANNUAL REPORT 2019

Dear Friends,

One of the most profound images I encountered all year occurred in the film A Beautiful Day in the Neighborhood. It's a film about Fred Rogers, and the way he intervenes in the life of a young journalist named Lloyd—a character loosely based on the real life journalist Tom Junod. Lloyd is cynical, angry, and lost, and Rogers takes an interest in him as a person, recognizing the pain that Lloyd is experiencing. And so in a series of scenes, Rogers performs therapeutic interventions that restore something of Lloyd's humanity. In the scene I have in mind, Rogers and Lloyd share a meal in a restaurant, and Rogers urges Lloyd to pause for a full minute to think about the people in his life for whom he is grateful. But then the camera does an extraordinary thing: it allows Rogers to gaze directly into the camera, so that we as viewers are invited into the scene. The film is helping us. As it all happens, a hush falls on the entire restaurant, and people crane their heads to observe the holiness of the moment. (I learned later that all the extras in that scene were real life friends of Fred Rogers, including his wife Joanne.) It's an extraordinary moment in a profound film, one that we need right now. Sitting in the theater, I felt Rogers' gaze fall upon me, and I felt...grateful.

That's the spirit with which I want to reflect back upon this year with all of you. There is much in the world that gives us cause to become cynical, angry, or despairing. There's much within our lives that feels broken. That stuff is real, and we mustn't ignore it. Sometimes we need such voices in our lives. But I would have us be a community that pauses often, just to sit in gratitude for the goodness that we find all around us. And as we reflect upon this past year, I would have us recall the many things that took place for which we can be grateful. With any luck, that same spirit of holiness may descend upon us when we do so.

Here are a few moments I can think of. This past spring (and early in the present year as well), Paul Verryn spent time with us, and opened the Bible to our eyes in a revelatory way. The Florence Griswold Museum chose to highlight the work that we accomplished as a faith community over the past several years with their exhibit "Nothing More American." We got to celebrate that exhibit twice, on opening night and at our annual Christmas party. We discovered a new model of sanctuary, and welcomed Jose Valentin Valentin into our community. Our work was featured nationally in the online UCC bulletin, recognizing our leadership in providing sanctuary for those at risk of deportation. We solidified new bonds of partnership with some of our allies in the immigration struggle here in New Haven and in New London. Malik and Zahida got their pizza business rebuilt, and are doing well. We've worked to keep the Torres family afloat while we continue to press a case for Glenda's return. Our young people traveled to the South to learn about civil rights in places like Montgomery and Selma, and then did it again in a visit to Ellis Island. Some of you traveled to Green Grass to renew the bonds of friendship with members of the Lakota Tribe, while some others of us traveled to Mexico to renew our relationship with the Benedictine Sisters of Cuernavaca. Those are all things for which I'm deeply grateful.

But as much as anything, I'm grateful for the smaller moments. For the moments of shared intimacy when you've let on about a struggle you're having, or during a hospital visit, or planning for the funeral of someone you loved. I'm grateful for those moments. I'm grateful for our worship services, and for a place that can ground us all from week to week amidst a confusing and dehumanizing cultural moment. I'm grateful for opportunities to be together, and to share with one another, like during the luncheon that followed our stewardship Sunday, or in the potlucks that have a way of happening from time to time. I'm grateful whenever I see you — all of you — walking through the door on Sunday mornings, or sitting in the pews. I'm simply glad to be together in our shared quest to find a deep source of spiritual wisdom in these times. Most of all, I'm grateful to be a part of such a congregation — of people willing to put themselves on the line, and to make a difference here and far away. There's so much to be grateful for, so much to celebrate about this place called The First Congregational Church of Old Lyme.

So take a moment. Whenever you read this, sit in silence for a little while. And recall all about this year for which you can be grateful, for which we can all be grateful. I hope it leads toward something like that moment of holiness, befalling the diners seated around Fred Rogers.

Looking back at where we've been is a wonderful exercise of the heart even if it's "just" for an annual report! Sometimes our lives, whether at home, work or in the wider world are moving so fast, appreciation for the journey can be missed altogether. So here we are...

My heart is full of gratitude for another year with you. In many ways, our Church life is an ongoing dynamic conversation about what and who we value on this human journey of faith, grace, life and community-building. As poet-member Marilyn Nelson wrote, What amazingness are we creating?

Our Sunday School program continues to flourish under the creative expertise of Coordinator, Lisa Doggart, and a dedicated team of parents and high school youth along with support from our Board of Youth Ed (BYE). Family membership is growing with 6 new families attending and each child a welcome addition to our energetic classrooms!

The breadth of activities we offer our children and youth from Sunday mornings to beach clean-ups to the Midnight Run and PF Sunday Night Soups continue to demonstrate our ongoing commitment to the practice of love made visible in the world near and far. Last spring, our Pilgrim Fellowship group went on a Civil Rights Trip through Atlanta, Birmingham and Selma with leaders, Lisa Doggart, Carleen Gerber, Allison Hine and Mary Tomassetti. I helped write a grant through our local Middlesex UCC which contributed to scholarships for the journey.

In the last year, our programming for our middle and high school Pilgrim Fellowship group focused on civil rights, immigration and our own personal experiences with racism and prejudice. A fall trip to Ellis Island was especially meaningful.

Our church immigration and sanctuary efforts have brought deep and abiding friendships for our whole congregation, including our Sunday school program. A December Christmas party at the Florence Griswold Museum celebrating the current exhibit, "Nothing More American" and our church commitments to these amazing families has enriched our whole community in ways that reach far beyond church walls. Thanks to efforts by Lina Tuck, our Chair of Immigration, and so many of our church and community volunteers, we've grown in our understanding of what a theology of hospitality means in real time as we expand our supports to include the Torres Family and asylum-seekers like Jose from Honduras. Writes the poet, Luis Alberto Urrea, "There is no them, there is only us."

Last March, I was part of the women's leadership team that led 24 travelers to Israel and Palestine on a Tree of Life partnership trip to Israel, Palestine and Jordan. I'm deeply grateful to have represented FCCOL on this journey with friends from the Berlin Mosque. Being able to bear witness to the alternative narrative of life under Occupation is to stand on holy and hard ground. I'm grateful that our partnership journeys continue to inform my life and ministry.

Throughout the year it has been a pleasure to plan and participate in programming that supports the spiritual life and pastoral care of our congregation. From preaching to pastoral visitation, to our Fall Women's Retreat and monthly Caregiver and Book group discussions, the year has been busy! Our shared ministry together continues to grow with additional seasonal offerings like summer retreat days, special worship services (Ash Wednesday and Blue Christmas service) and other programs which

enrich the life of our church and community. In addition, we started a pastoral care acapella group for home and hospice visitation called The Agape Singers and thank Lisa Feltes for her music leadership.

I'm humbled as well by your dedication and generosity as volunteers at the Shoreline Food pantry (SSKP) feeding and supporting hungry neighbors. While the challenges this year have been great, our volunteers are the steady hum that keep doors open and neighbors being fed. In addition, the enormous dedication of our Deacons, Trustees, Missions Board, LBS members and many active committees remain a source of ongoing inspiration to me. Thank you for all you do for the sake of our community and ministries. Come July, when our church transforms into the White Elephant Sale and back again, it is an astounding event to participate in.

Working in partnership with Steve and Carleen is an ongoing privilege and joy. Our church office staff with Bob, Odile, Teri, Mark, and Joanie contribute so much to the life and daily operations of FCCOL. Above all, thank YOU for your loving witness as a community of deep care in the world day in and day out

2019 ANNUAL REPORT FROM ASSOCIATE MINISTER

In this past year I have, perhaps, come to better understand what it might mean to be a "less-than-full-time" minister. Don and I are able to travel a little more easily, and I am grateful for that. I surely attend significantly fewer nighttime meetings than I used to, which is a relief.

I continue to work primarily with the boards of Missions and Stewardship, and with Trustees and Deacons as needed; as well as substituting for Simon at the organ bench occasionally. It's fun to be at the organ once again. I also help coordinate the fabric of pastoral care which enables Steve, Laura and I to work together to visit and support our families in times of need.

Our Board of Missions oversees the outreach work that takes place near and far. Susan Beeman has stepped into the role of leadership on that board, and I am particularly grateful for her wisdom and insights as this past year has been a year of challenge for the Saturday soup kitchen and food pantry ministry, which the Shoreline Soup Kitchens and Pantries organization manages at our church facility. This is a large and challenging enterprise, for our church, but also for the leadership of SSKP. As their annual appeal funds have decreased, they have begun to wrestle with the reality that they cannot afford to serve guests residing out of the 11-town region which SSKP was chartered to serve. And we at the church have had to wrestle with just how we can continue to serve the folks who have become accustomed to coming to us on Saturdays for help with food insecurity. I am grateful to all the volunteers who have stayed loyal to the work we seek to do, and I am grateful that the Board of SSKP continues to work with us to try to envision how this critical ministry can continue. As I write this report, our visioning work continues. And I am hopeful for the future and grateful to everyone for the support they continue to give so generously. I am determined to find solutions. In this country, where there are plentiful resources, it does not make sense for people to go hungry. And yet — they do.

The mission board helps with the needs of the active refugee resettlement and immigration teams as much as possible. Lina Tuck continues to provide incredibly valuable leadership with our immigration work. And Scott Harris, working with Kathy Kronholm of St. Ann's Episcopal Church, leads the refugee resettlement team. We are fortunate to have them serve with such generosity of spirit.

We continue to have teams of volunteers at both the New London meal site and the Old Lyme soup kitchen site. So many of you volunteer that it's hard to thank everyone — but surely Julie Kuja deserves special mention for coordinating the New London meal enterprise for so many years.

Our partnership teams remain strong, with a journey to Green Grass in June. Also to Palestine and Israel in March of this past year, which Laura helped to lead. Our visits to Haiti under the leadership of Becky and Ted Crosby have been curtailed temporarily due to political unrest in Haiti, but we remain hopeful that another journey will be planned soon. A second journey to Mexico to visit the Guadalupe Retreat center in Cuernavaca took place in October; and a youth trip for our Senior and Junior High Pilgrim Fellowship to Alabama enabled our young people to study the history of the civil rights struggle in this country. All of our journeys reflect our deep commitment to the power and worth of experiential mission education; a commitment that has invigorated our mission work for the past thirty years.

I continue to work with the Board of Stewardship, ably led by Mary Kate Cox and a great team of creative and hard workers. In a time when many churches are struggling, we have a broad base of generous supporters. And so we can continue to be able to expand all the ways in which we work together; to serve, to educate, to worship and to try to build a place that Clarence Jordan called "a demonstration plot for the kingdom of God."

I am grateful for the wonderful spirit of camaraderie and fellowship that blesses our ministers and church staff. I am also grateful for the countless ways you, the members and friends of this congregation, have offered encouragement and support over this past year to me and to my family. This is a richly rewarding place to serve; and the credit for that goes to each and every one in this wonderfully diverse and generous congregation.

TREE OF LIFE 2019 PARTNERSHIP REPORT

In winter in the candlelight in our windows and the lights of our Christmas decorations we remember that all the darkness in the world cannot extinguish the light of a single candle. During this season, I've also contemplated the "Night Journey" of the Prophet Mohammad, peace be upon him.

In the year 621, the Prophet made a journey by night from the Great Mosque in Mecca to what is now The Dome of the Rock, Al Aqsa Mosque in Jerusalem. On this journey, he rode a winged white horse, by the name of Buraq (yes, that's the same word as Barack Obama's first name), translated as "Lightning" and he prayed with the great prophets, Abraham, Moses and Jesus. The name of his flying horse, "Lightning," lends new and more hopeful meaning to the poetic words of the playwright, Tennessee Williams:

Nowadays the world is lit by lightning.

In the world's darkness, we all seek those flashes of illumination wherever they may be found, and as we try to navigate our lives, we all rely upon the prophetic voices of those who have come before us.

On the night in which Jesus was born in a manger, Magi, followers of Zoraster, were even then en route to Bethlehem. Where Mohammad rode "Lightning," the Magi, following a bright star in the East, rode their camels some 2000 miles to the birthplace of one who would endeavor to bring God's Love to all Creation. In his life and teachings, he would remind us that, "God became as we are so that we might become as God is." (William Blake). Or, as W.H. Auden said, "To discover how to be human now is the reason we follow the star."

Much earlier, a Jewish shepherd in the land of Midian, saw a burning bush, which ignited his passion to free his people from the injustices from which they suffered. This marked the beginning of a long journey across the wilderness in search of a more promising future. Struggling with his people's tribalism and quarrels for power, Moses said, "Would that all the Lord's people were prophets." (The Book of Numbers.) Heeding that plea, historically, Jews have been at the forefront of struggles for Human Rights. Tree of Life is honored to have Jewish voices of conscience on our Board of Directors, Mike Winterfield and Mark Braverman.

As we are overwhelmed by the darkness of the land, with all its political corruption, greed, nationalism, tribalism, fear and war, we need to learn from the wisdom of the prophets, past and present, so that we too can add our own prophetic voices to this troubled world.

Each year, like Mohammad, Tree of Life travels to the Holy Land allowing travelers to pray with the prophets of old. Like the Magi, we travel to the West Bank City of Bethlehem with the hope that we might become the children of God we were created to be. In many prophetic voices of conscience — Jewish, Christian and Muslim — we have the privilege of sitting at the feet of those who struggle to make this a better world for all Creation. In March we were pleased to have Laura Fitzpatrick Nager, Ann Perry and Ellen Perry take part in our March "Mothers of a New Creation" journey, with Laura serving as one of our chaplains. Tragically, one of our travelers, Nadia Milleron learned just the day before departure that her daughter was among those who died on a Boeing flight in Ethiopia. Unable to go, Nadia and her family were very much in the prayers of the 23 travelers and those of us back home.

One of the goals of these journeys is not only to learn from the prophetic voices of Palestinian, Syrian and Israeli voices of conscience, but also to help our travelers to reclaim their own prophetic voices. We especially want to provide this opportunity for young people, and thanks to the generous support of members and friends of our church and our Tree of Life community, we were able to offer a record number of 7 travel scholarships to college age young people.

Thanks in large part to the inspired leadership of John Fussell assisted by many members of our church, especially Fred Behringer, Tree of Life placed a high priority on Advocacy initiatives, especially in support of Representative Betty McCollum's legislation, H.R. 2407 in defense against the incarceration and mistreatment of Palestinian children. Many organizations and individuals signed on as endorsers of our resolution in support of that bill, but many more are needed if we are to persuade our congressional representatives to co-sponsor this bill. Also, we have remained ever vigilant and responsive to anti-BDS legislations wherever it has surfaced. In our Advocacy efforts we work in close partnership with Jewish Voice for Peace — New Haven, the U.S. Campaign for Palestinian Rights, Defense for Children International - Palestine and members of the Trade Union Community. Also, in partnership with Friends of Sabeel North America, with special thanks for the leadership of Ann Perry, we raised a voice of opposition to Christians United for Israel led by Rev. John Hagee.

For our Fall Tree of Life Series, "Will There Really Be a Morning," we were most honored to feature the remarkable parents of Rachel Corrie — Cindy and Craig Corrie. Also, we were very pleased to welcome young Palestinian visitors from Hebron and Bethlehem — Rawan and Sofian, Dalia, Tamer, Nadine and 2 year old Hani. Sadly, Lama from Gaza wasn't able to get the permit and visa to come, but we were all touched by her video from Gaza that we offered at each event. These young people shared their poignant stories of life under occupation and demonstrated the dignity, resilience and tenacity of their Palestinian identities. We all should be very grateful that Mazin Qumsiyeh, one of our highly esteemed advisors, met with them to help prepare them for their visit. On Sunday October 20th, we were most grateful that our church was able to host our visitors during the morning worship services.

Thanks to the prophetic voices of Craig, Cindy, Mark Braverman, Rabbi Meryl Crean of Jewish Voice for Peace and Meera Shah of Palestine Legal, those in attendance at our various venues learned how we, the American people, need to be the answer to that question, "Will There Really Be a Morning." In presentations at the Artists Collective in Hartford, the morning services of the First Congregational Church of Old Lyme, the morning service of Avon Congregational Church, Palestine Museum, a visit to the Center for Palestine Studies at Columbia University, a living room on Riverside Drive in NYC, the Kamora Cultural Center in Hartford, a partnership between a church and mosque in Avon, Yale Law School and UConn School of Law, Trinity College, a classroom at UConn Storrs, a Unitarian Universalist Community in Keene, New Hampshire, Episcopal and Lutheran churches and public schools on Cape Cod nearly 1500 benefitted from these prophetic voices and hopefully were inspired to find their own voices of conscience.

Thanks to the dedication of Nick Westbrook who volunteers with our Palestinian olive oil, zatar and olive oil soap sales, we sold a record 1.5 tons of olive oil. In this program, called "Education In A Bottle," all the proceeds help to provide college education for Palestinian students at Bethlehem University, Al Quds, Beirzeit and other educational institutions in Palestine. With the sale of every bottle, we provide an infusion of hope for Palestinian families who put a high priority on higher education.

Finally, I want to thank the Board of Missions, the Ladies Benevolent Society and all the members and friends of our congregation for your generous support. The Arabic word, Siraj, means torch, and so I thank this church for helping Tree of Life to be a Siraj — a light in the darkness, sometimes a barely flickering candlelight, sometimes more like Lightning streaking across the sky, sometimes a Burning Bush, sometime a word of enlightenment, a Morning Star, a reminder, that thanks to the prophetic voice that God has given us that yes, indeed, "There Really Will Be a Morning!" Let us live in that hope!

REFUGEE RESETTLEMENT COMMITTEE OF OLD LYME 2019 REPORT

The Refugee Resettlement Committee is an ecumenical committee composed of people not only from St. Ann's Episcopal Church, Christ the King Roman Catholic Church, and First Congregational Church, but also members of the community who pool their efforts and talents to help refugee families settle in Connecticut. The committee assists in arranging, among other things, health care referrals, housing, social services, food supplies, school enrollment, English instructions, temporary financial assistance, transportation, and mutual support for families who are need of starting a new life. The overall goal of the committee is to work with families to help them become independent within one year. As in the past, the committee works under the guidance of IRIS, the Integrated Refugee and Immigration Service, New Haven Connecticut

This past year the committee helped resettle the Al Khafagi family—Ghassan, Maysam, Lilas, and Ali—who arrived on July 19th from Iraq. Despite the fact that the family seemed to be getting settled in their new home here in Old Lyme, due to a serious illness with Ghassan's mother, who is in Iraq, the family returned to Iraq on October 19, 2019 with the understanding that they would return within one month. As much as we all anticipated the family returning within the month their plans changed and they decided to remain in Iraq. According the IRIS guidelines our responsibilities for the family ended on November 20th. As a committee we wish them health and safety in Iraq.

As for Kazadi Joseph, Kabanga Martine, and their children, Mariamme, Drysile, and Joseph, Jr., they still occupy the refugee resettlement home on Roger's Lake Trail. As agreed, they will remain in the house through June, 2020 after which they will be living independently in a residence of their own choosing. We are happy to have been able to help them at this new stage in their lives here in Connecticut.

IMMIGRANT ASSISTANCE COMMITTEE ANNUAL REPORT 2019

Mission Statement

The First Congregational Church of Old Lyme is a community of faith who cares about the world we live in, whether it is right outside our door or half a world away.

During this grave immigration crisis, we believe in strong partnerships within our community that foster trust and hope to those in fear of deportation. By offering sanctuary, education and financial assistance for legal counsel, we offer grace and hope to families in need, working together through our acceptance of all that we are, a land of immigrants. The Immigrant Assistance Committee was formed in March of 2017 at the request of the FCCOL ministerial staff and with the approval of the FCCOL Board of Deacons.

Objectives and Goals

Education - Immigrant Rights Workshops, Family Preparedness Plans, other workshops as needed Program/Seminars - Wider Community Education, Accompaniment Training, Civic Action (marches, congressional calls, legislative awareness)

Accompaniment - ICE appointments, Legal Appointments, and Court appearances

Partnership Outreach - Civic Organizations and Educational Organizations working on Immigrant Rights

Critical Needs - critical living needs like food and housing

Legal Assistance - building a resource of available programs to assist families with legal concerns Fundraising - provide financial assistance for families needing legal counsel, provide assistance for critical living needs.

Sanctuary — create a physical space for our church community to provide sanctuary to person or persons in imminent threat of deportation or seeking asylum relief.

Accomplishments for 2019

The Immigrant Assistance Committee has worked together to achieve another successful year. We have been able to form community partnerships, assist families in deportation crisis and provide a financial mode of assistance through church and community wide donations. A total of \$20,243 has been donated to help with our ongoing work in 2019.

This Committee is a responsive committee that forms into action as requests arise. Our mode of communication is primarily through email updates and committee meetings are scheduled on an as needed basis.

We continue to make an impact one family at a time by assisting families who are in threat of deportation. Below is a synopsis of our present cases.

- Old Lyme resident from Guatemala Mom is a single mother of an American born daughter
 and was referred to us through a patron of the Food Pantry. She is presently in deportation
 proceedings. FCCOL has assisted this family with legal fees, accompaniment to Immigration
 check in appointments, court appearances and legal appointments. Through community
 outreach, we were able to secure a pro bono attorney to represent her. The committee was
 also able to assist this family with a wide array of furniture donations for their apartment
 move. Our volunteers continue to accompany Guisela for her Immigration checkins.
- New London resident from Haiti Mom is a single mother of two American born daughters
 and was referred to us through a patron of the Food Pantry. This mother has been in the
 United States for many years under TPS (Temporary Protective Status) from Haiti. As of
 November 2017, the United States government has ended TPS for Haiti. The committee was
 able to provide funds for a legal consultation to determine if any legal avenues are available
 for permanent residency. We have also provided funding for her upcoming TPS registration.

As of November of 2019, TPS for Haiti has been extended until January 2021, we will continue to be available should this family need our assistance in the future.

- Sanctuary Our committee has been asked to provide Sanctuary to four people to date. We were thankful that the first two requests were not necessary as stays were granted for each of these cases. A stay allows the person in deportation mode to stay in the United States while their court case goes through the immigration system. The third case was for Mariano Cardoso. Mariano was provided Sanctuary on December 14th. As all of the preparations were being executed, Mariano was given a stay by Immigration. Mariano was able to return home with his family on December 15th. His court case is ongoing and we continue to be very hopeful for Mariano's case to succeed. On March 19, 2018 we accepted our fourth case. Malik Naveed bin Rehman and Zahida Altaf accepted sanctuary at FCCOL. Our many church community volunteers provided sanctuary for 212 days. Malik and Zahida are now back in New Britain with their daughter Roniya. Their immigration case continues and we will accompany them on their continued journey through the immigration system.
- Asylum Seeker: Jose, a young man from Honduras. We were asked by the CT Bail Fund to assist a
 young man, Jose, who is looking to seek asylum from gang violence in Honduras. The
 committee is providing support with living accommodations, education and hospitality in our
 loving community. His legal needs are being met by New Haven Legal Aid. This is a partnership
 venture with FCCOL, All Souls New London, CT Bail Fund and New Haven Legal Aid.

Goals for 2020

2020 will be a year of legal decisions for some of our families, Malik and Zahida await the news of their appeal to the Second Circuit, Miguel awaits the return of his wife Glenda from Honduras and Jose awaits news on the acceptance of his asylum application. The Committee will continue to support our beloved families as well as new ones that may come our way in the coming new year. We will continue to find ways to provide information on immigrant rights to our wider community. We will work on initiatives to contact and lobby our congressional leaders to help provide a legal pathway to permanent residency and citizenship.

THE FIRST CONGREGATIONAL CHURCH OF OLD LYME TREASURER'S REPORT – YEAR END 2019

Summary Overview

Total Operating* Revenues for the year 2019 were \$835,376, or \$19,435 under the budgeted amount of \$854,811. Total expenses for the year were \$834,847, also under budget by \$19,964. Therefore, the bottom line resulted in a very small surplus of \$529, essentially in balance. These operating results are summarized on the following page #18. Account-by-account details are on the following pages, #19 through #24.

Revenues

The under budget revenue resulted substantially to a shortfall in the Pledges and Offerings category. Specifically the collection of Current Pledge amounts were under budget by about \$34,000. While collections exceeded our experience in 2018, this shortfall was due primarily to some members becoming inactive, moved or deceased during the year. This shortfall in pledge collections was partially offset by plate collections and members who contributed but did not pledge. The Pledges and Offerings category shortfall was partially offset by better than budgeted revenues from Building Usage income.

Expenses

The under budget result in expenses was, as usual, due to a combination of over and under budget performances. The categories of Christian Education, Property and Lay Employees were over budget because of (1) growing Sunday School and Pilgrim Fellowship programs, (2) major necessary improvements to the Parsonage, and (3) summer coverage in the office manager position and greater than expected overtime costs. The categories of Music, Office Expense, Benevolences and Other Expenses were under budget and offset the above over categories and shortfall in revenues by necessary cutbacks in Benevolence spending, and by making a lower than budgeted loan repayment to the Endowment Fund.

Year-End Surplus

The modest \$529 surplus amount will be automatically applied to reduce a negative equity entry on the balance sheet that resulted from deficits in previous years.



A NEW WAY TO LOOK AT OUR CHURCH'S BUDGET



MISSION OUTREACH

Our Board of Missions (through the operating budget), and the Ladies Benevolent Society (through the White Elephant Sale) generously support over 75 local and international charities and missions each year. We also nurture partnerships with churches in South Africa, a Native American community in South Dakota, Koinonia Farm in Georgia, Beit Sahour in Palestine, a school in Harlem, and a foundation in Haiti.

COMMUNITY OUTREACH

We are the largest site in SE Connecticut for the Shoreline Food Pantries and Soup Kitchens, distributing groceries and serving meals to at least 100 families each week. We also host the local Cub Scout Troop, Red Cross drives, blood Musical Masterworks concerts. Visiting Nurse Association activities, AA meetings, and much, much more.

WORSHIP

We conduct inspiring worship services every Sunday morning in our historic Meetinghouse and at the South Lyme Chapel, to which ALL are welcome. These are in addition to special services during the Christmas, Easter, Lenten and Thanksgiving seasons. Our 3 ministers deliver consistently inspiring and challenging sermons, and the services provide quality time for meditation, prayer, and the enjoyment of sacred music.

\$831,648 CHRISTIAN EDUCATION We have a vibrant Sunday School program called "God's Neighborhood"

School program called Neighborhood" meeting every Sunday and featuring several "diversity Sundays" to nurture understanding of other faiths and cultures. There are active Junior and Senior High Fellowship groups, Bible study and book groups, poetry and writing groups. And the Adult Forum presentations every Sunday provide discussions of challenging issues.

Our extensive music programs enhance the worship services and lives of many participants: A 45+ person Senior Choir, a seasonal bell choir, the Children's choir, a seasonal bell choir, music sessions during "God's Neighborhood" and special concerts provide opportunities to enjoy and participate in music year-round. We are grateful for our professional Directors and Soloists for their skillful leadership of these programs.

Our ministers are available at all times for the pastoral care needs of our congregation and other members of the community. Visits to homes, hospitals and nursing homes, memorial services and grief counseling, pre-marriage and baptism counseling are all part of their gifts of service. Grief support, cancer support and caregiver support groups are also held when these are needed. The Minister's Discretionary Fund provides financial support to local people in need.

OUR CHURCH IS INDEED A PLACE OF GRACE

PROPOSED 2020 FCCOL BUDGET OVERVIEW

Preparation of the annual church budget is the responsibility of the Budget Committee of the Board of Trustees. Each year in the fall, the different boards, committees, church staff and ministers are asked by the Budget Committee for estimates of expenses for the coming year based on their plans and programs. So the church budgeting is very much a bottom up process. At the same time the Budget Committee works with the church treasurer and the Board of Stewardship to estimate the church income for the following year. The final budget is then prepared as an iterative process, balancing the expense estimates with the projected income. The Board of Trustees approves the proposed budget at their January meeting, and presents this proposal at the church annual meeting later in January for congregational approval. Bob McCracken, church treasurer, headed the Budget Committee this year. The 2020 Church budget is shown on Pages 31 through 37 of this annual report. Highlights are as follows:

REVENUES

Total revenues for 2020 are budgeted at \$831,648, a decrease of \$23,163 from 2019. This decrease is due primarily to a more realistic assessment of stewardship campaign pledge collections. The average pledge continues to increase, but the number of people who pledge has declined slightly over the past several years. We continue to receive strong support from the Ladies Benevolent Society (shown in "Pledges and Offerings") and from the Church's endowment fund (shown in "Other Income").

EXPENSES

The budgeting of expenses for 2020 represented several tradeoffs to arrive at a balanced budget projection. The Personnel Committee strongly recommended, and the Board of Trustees unanimously agreed, that salary increases were needed for the Senior Minister, the Director of Christian Education and the Church Administrator, in order to bring their level of compensation more in line with UCC and national standards and in recognition of their significant responsibilities and accomplishments.

These increases and the lower revenues were offset by reductions in the Music, Church Office, Property, Lay Employees and Benevolences accounts. These savings did not negatively impact the programs or functions of these departments, except for Benevolence giving and Property (Major Maintenance).

Benevolence giving by the Board of Missions was reduced from past year's level of \$80,000 to \$72,000. It is the Trustees intention to restore Benevolence giving to the \$80,000 level when and if the 2020 Stewardship Campaign comes in higher than currently projected or if special additional contributions make this possible.

The Major Maintenance accounts were reduced from \$40,000 in 2019 to \$20,000 this year. No critical current projects had to be postponed, but history shows that this level is not sufficient over the long term.

The 2020 budget summary and comparison to 2019 is shown on the following page, and the account-by-account detail is presented on pages #32 through #37.

We continued to work on reducing major maintenance costs in 2019. As in 2018, the committee focused only on critical projects or projects supported by outside funding sources. The committee completed the following projects, as approved by the Trustees, in 2019:

- The Committee began the year with the completion of the classroom flooring replacement. This
 project was funded by the remaining funds of the Ingalls Family gift which installed a new HVAC
 system in the Sunday School area, completed in 2018.
- Work continued at the Parsonage to remediate the ongoing moisture challenge. A completely

BUDGET

Preparation of the annual church budget is the responsibility of the Budget Committee of the Board of Trustees. Each year in the fall, the different boards, committees, church staff and ministers are asked by the Budget Committee for estimates of expenses for the coming year based on their plans and programs, so church budgeting is very much a bottom up process. At the same time the Budget Committee works with the church treasurer and the Board of Stewardship to estimate the church income for the following year. The final budget is then prepared as an iterative process, balancing the expense estimates with the projected income. The Board of Trustees reviews the draft budget at its December meeting and approves the final proposed budget at its January meeting. The proposed budget is presented to the congregation at the church annual meeting in January for congregational approval. The 2020 Church budget is shown on pages #30 through #37 of this annual report.

PERSONNEL

Throughout the year, Bob McCracken kept our committee informed on personnel related matters as they arose. We contributed to the dialogue on personnel issues whenever it was appropriate.

This year the Church had the responsibility of hiring a new Office Manager, following the passing of Joan Kelley. Joan had worked very capably and cheerfully as the Office Manager for 12 years, so finding her successor was not an easy task. The Church undertook this responsibility in a professional manner, identifying several qualified candidates who were very interested in the position. Each of the finalists was interviewed multiple times. After the interviews were complete, we prepared written summaries for the ministers, who made the final selection. As you all know, the Church hired Odile Irakiza, who has been settling into her new role very nicely.

As we entered the Budget season, I met with Bob McCracken and Faye Richardson, Chair of Trustees, to review the current pay and benefits packages for all Church employees and independent contractors. While current pay levels for the church staff remain generally in line with data provided by the UCC and the Christianity Today national surveys, we did recommend increases for the Senior Minister and the Church Administrator in 2020 to bring them closer in line with these guidelines and to recognize their substantial leadership contributions. We acknowledge that we are on the high side of the average, but appropriate for the size of our Church.

The final decisions re compensation will take place at the upcoming January 2020 Trustees meeting and will go into effect following the vote at the Annual Meeting. We also reviewed the health and life insurance packages for ministers and staff. We acknowledged that health insurance costs represent a large and growing portion of personnel-related expenses.

The ministers and others are paid a set salary, with these salaries noted in the budget spreadsheet. For those employees who are paid on an hourly basis, hours for the year have been estimated, with expected total pay listed on the budget spreadsheet.

Throughout the year, I was frequently reminded of how fortunate we are to have such a professional staff working in the Church office, under the leadership of Bob McCracken, our Church Administrator. Respectfully submitted, Gregory A. Hack, Chair

BOARD OF STEWARDSHIP - ANNUAL REPORT 2019

The Board of Stewardship is responsible for securing financial support for the church. This is accomplished primarily through our annual stewardship campaign, which accounts for over four-fifths of the church's annual revenue.

We designed the 2020 Campaign under the direction of Rev. Steve Jungkeit and John Kiker who led us through a discussion of inspiring themes and persuasive language in support of "Where your treasure is there will your heart be also." We wanted our stewardship campaign to ask the key questions: when so much is at stake for so many, what is our treasure and where is our heart as a church? From the very beginning we wanted this to be a highly participatory process, to hear directly from our members about ways in which the church changes lives -- our own and those of others, in both our pews and in the world.

On Stewardship Sunday Steve delivered a truly inspiring sermon in support of these messages and then the congregation convened to discuss these themes in **Heart to Heart: A Community Conversation**. We hoped to have 50 participants; yet when all of the chairs were found to accommodate a record crowd, we had **over 100 members participate!** At table after table people spoke of their shared appreciation for all aspects of the church. In moving testimonials members shared their own faith journeys, the church activities they valued the most and their desire to be more; to do more. Bottom line? Our heart is where it has always been: in bringing about good for the people in our family, our congregation, our community and world. And our treasure remains constant: making a meaningful difference in our lives and the lives of others by following the timeless teaching of "Love thy neighbor as thyself." Special thanks to Rev. Laura Fitzpatrick-Nager, Allison Hine and Tom Grant for their leadership of this transformative event.

We appreciate all who have listened and given — thank you!!Our current 2020 campaign to date has resulted in \$557,000 from 287 pledges, against the goal of \$600,000. Our average pledge is almost \$100 higher than last year. As we look at the individual results, year to year, we are encouraged overall. Over 92% of those who pledged have increased their pledge, maintained their 2019 level or are new pledges. If you have not yet made your pledge, we hope you can find the means to support our church's good works.

Every year we have a growing list of those to thank: Senior Associate Minister, Laura Fitzpatrick-Nager, Associate Minister, Carleen Gerber, Treasurer, Bob McCracken and Trustee John Kiker for their invaluable knowledge, guidance and support, and to Joanie May, who flawlessly develops, segments, and maintains our mailing lists. We also depend heavily on Teri Gedrys, who enters and maintains our pledge data, FCCOL Office Manager, Odile who makes our communications come to life visually, and Wendy Knight for her careful work updating our donor board each week.

ENDOWMENT COMMITTEE REPORT 2019

The Endowment Committee is responsible for the management and investment of all gifts, contributions, and bequests not specifically designated. Such funds are placed in a perpetual Endowment Fund. The objectives for management of the Fund are (a) preservation and growth of the Fund to ensure support of the Church if needed in times of severe economic downturn, and/or for other unusual and compelling needs, and (b) to support the annual operating budget of the Church.

For the 2019 budget, the Endowment provided the Church with operating funds of \$105,311, which was 5% of the previous three-year average year end value of the Fund, in accordance with the Church's bylaws.

The Endowment portfolio maintains a long-term asset allocation objective of 70% stocks and 30% bonds. The allocation varies around this objective as market and economic conditions evolve. In 2019, the Endowment returned 23.4%. The bond allocation of the portfolio is conservatively invested, principally with high-quality, shorter-term securities. We have completed our divestment of fossil fuel holdings.

The value of the church Preservation Fund at the end of 2019 was \$319,012. This included \$73,959 received from our church's longtime equity in the Old Lyme Shopping Center. In addition, there are two bequests totaling \$200,000 designated in wills for this Fund.

The investment results of the Endowment in 2019, and since inception (1988), compare favorably to the endowments targeted asset allocation index consisting of 70% stocks and 30% fixed income.

BOARD OF MISSIONS ANNUAL REPORT 2019

In 2019 the members of the Board of Missions have worked to support the social justice and missions -based goals of the congregation within budgetary allowances.

To achieve this, funding supported five primary beneficiaries through the Mission Education funds. These are the Tree of Life Educational Fund, the Crosby Fund for Haitian Education, the Green Grass Partnership in South Dakota, Youth Civil Rights and the South African Partnership. Mission education funds are used to send people from here to a partnership location or to help someone travel to us.

Mission Funds also support the UCC in the form of an annual distribution (part of this allocation is required for FCCOL to maintain active membership in the UCC).

Direct Partner Support Funding allows us to interface in partnership activities with agencies with whom we are engaged. Partnership Committees within our church community work on activities and special events. Additionally, Outreach is provided to a wide range of local and international agencies to support work for at risk populations.

As of December 2019, 84.3% of the budgeted \$80,000.00 was dispersed.

Of dispersed funds, 27.4% went to local charities such as the Covenant Shelter, Safe Futures, Habitat for Humanity, FRESH New London, the Alliance for Living, the Homeless Hospitality Center, and many others. 24.5% was used to meet UCC obligations and support its charitable work, 18.3% supported church partnerships, 20.2% was contributed to educational opportunities related to mission work and 9.6% supported FCCOL projects and connections.

We encourage FCCOL members to bring organizations or causes which meet the mission and goals of the church and deserve financial support to the attention of any board member.

Thank you to our Board members for their thoughtful and dedicated work: Allyson Cotton, Dawn Clark, Nancy Mol, Mary Bradford, Eliza Beth Hamilton, and Stephanie Kenny. Thanks also to our Deacon representative, Deb Heminway for her contributions throughout the year and our minister representatives, Carleen Gerber, and Laura Fitzpatrick-Nager for their guidance and expertise.

MISSION OUTREACH AT THE FIRST CONGREGATIONAL CHURCH OF OLD LYME IN 2019

This year's Christmas Eve offering will be used to support the Minister's Discretionary Fund of the First Congregational Church. This fund, which dispersed about \$49,000 this past year, is used to support families in need. It is supported by this church's annual budget, by the Ladies Benevolent Society of this church, and, most importantly, by the annual Christmas Eve collection. We ask that you give as generously as you can.

In this past year, \$72,000 was dispersed by the Board of Missions to agencies within our community, New London County and the world. An additional \$81,384 was given by the Ladies Benevolent Society of our church — an extraordinary amount made possible by the hard work and success of the White Elephant Sale.

Additionally, \$26,180 was given to our Mission Education work in the form of travel expenses paid by the individuals who participated in our trips to Green Grass, South Dakota, Guadalupe Center of Cuernavacca Mexico, Wings of Justice for Youth travelling to experience landmark Civil Rights sites, and Tree of Life Educational journey to Palestine, Israel and Jordan.

Special gifts totaling \$7,346 were made to help sustain the Refugee House in Rogers Lake. And an additional \$7,099 was contributed to meet various needs of the families who have lived there. A large number of volunteers from all three of our area churches continue to give generously of their time in this important work.

A total of \$20,243 was given by individuals and families to support the work of our Immigration and Sanctuary Committees. And, once again, a veritable goodwill army of people assisted our sanctuary families by offering precious companionship during their time with us.

\$7,741 was raised for the "One Great Hour of Sharing" mission work of the UCC, and an additional \$3,234 was given to support the operation of the food pantry which takes place here every Saturday.

Thus, in total, more than \$274,000 in aid and support was made possible through the generosity of the people of this church.

GREEN GRASS PARTNERSHIP / PARTNERSHIP CO-OPERATIVE ~ 2019 ANNUAL REPORT

In June of 2019, fourteen members and friends of the First Congregational Church of Old Lyme traveled to the small community of Green Grass located on the Chevenne River Reservation in South Dakota. The journey was led by Carleen Gerber and Stephanie Kenny. The trip began with a visit to Bear Butte, a sacred mountain to the Lakota people. Travis Harden, his son Wakinyan, grandson Kaison, Kaida, Amelia, Winona Kasto and several of her family members, joined the group for the climb. It was fun to have the group with us on the climb. Travis sang songs for his relatives and we shared stories and reflections of life on the Reservation as we made our way to the top, some 4,000 feet above sea level. Afterward, we made our way toward Green Grass, landing at The Limit Lodge in Timber Lake, home base for the week. The days were filled with art projects, amazing conversations and adventures to the Moreau River to search for fossils and sacred stones. We planted trees and picked turnips, cooked meals for 50+ people and rode François's beautiful horses. Oscar High Elk, in advance of our arrival, had set up an obstacle course for the children including a water balloon fight and trampoline. He even prepped the field for horseshoes and a pick-up game of kickball. Through our annual Native Taco fundraiser here at FCCOL, the Partnership was able to purchase a volleyball set, sewing machines, fabric and accessories to make ribbon shirts and skirts, and of course much needed supplies for the community building like toilet paper and cleaning supplies. We also held our annual Tribal Crafts buying day, which served over 50 people and pumped over \$9,000 into this community of craftsmen. Our trip concluded with an amazing drive through Badlands National Park at sunset, simply breathtaking.

On behalf of the Green Grass Committee, I'd like to say thank you. Your support makes it possible for our communities to share in a vision and build on a partnership that is now 35 years old! HAITIAN OUTREACH COMMITTEE 2019

The Haitian Outreach Committee strives to engage the congregation in the activities and work of the Crosby Fund for Haitian Education and the current events in Haiti. This past year, the political unrest that began in Haiti in July 2018 continued through 2019. Due to this instability, riots and roadblocks, the Senior Pilgrim Fellowship Annual Trip and all other visitor exchange programs were canceled. We hope to resume our student and visitor exchange program in July of 2020. Becky and Ted Crosby continued their travel to Haiti in 2019, and they ask the congregation to keep the people of Haiti in their prayers. Food insecurity is a serious problem now caused by the economic crisis. It is estimated that 60% of the population or 6.6 million people are undernourished.

The partnership with our church continues to be a ray of hope for the Haitian people living in the region of Deschapelles. This year we helped the community in the following ways:

- The Board of Missions of FCCOL and the Ladies Benevolent Society support the scholarship
 program of the Crosby Fund for Haitian Education. These funds pay for Haitian students from prek to university to go to school in Haiti. For more information see our website
 <www.crosbyfund.org>.
- The Partnership Co-operative shop in our church offers for sale Haitian art, Lakota crafts and Palestinian goods. This past year \$10,878 of Haitian art was sold. 100% of these funds directly support 68 artists of the Artibonite Valley. For some, this is their sole annual income. Thank you to all our customers!!
- The annual Haitian dinner sponsored by the LBS was in May and close to 100 people attended.
 Vaudy Jean Baptiste and Fednor Sidort, our Haitian Program Director and Program Administrator
 of the Crosby Fund, attended the dinner and spoke during the event. Becky Crosby offered an
 update on their work, which provides scholarship funding and support for 510 Haitian students
 from kindergarten to university study, as well as the programs of the new Education Center that
 focusses on tutoring, adult literacy and special educational seminars for students and teachers.
- Ladies Who Stitch made dresses, backpacks and collected t-shirts, blue-jeans, and underwear for the children of Haiti. These items are greatly appreciated by the families in our community.
- Pencils and other school supplies were collected by our God's Neighborhood children and members of the congregation. These school supplies are given to schools in the very rural areas of Haiti.

The new guest house is finished and ready to receive visitors when Haiti is calm once again. It provides beds for 10 guests. We have a wonderful cook names, Erline, who will introduce you to Haitian cuisine. With the new Education Center and guest house, we hope you will come and visit us in Haiti and witness our program first-hand. If you are interested in visiting Haiti, please speak to Becky Crosby, our Minister for Haitian Outreach and Executive Director of the Crosby Fund program.

LADIES BENEVOLENT SOCIETY ~ 2019 ANNUAL REPORT

Throughout 2019, the LBS continued to honor their mission statement by providing benefits and support to our church, our congregation, and to as many worthy missions as possible.

"The purpose of this organization shall be to cultivate the Spirit of Christ in every area of human life and to enlist the community in a fellowship of worship, education, service and giving, and to support the programs of the First Congregational Church of Old Lyme as it serves the community, the state, and throughout the World."

The board continued to host six luncheons during the year (three each in the spring and the fall) to promote and provide fellowship and education. The programs offered, following each luncheon, covered an eclectic range of topics and interests. There were musical groups, talks by local authors, and presentations by missions supported by the LBS.

The Haitian Dinner in May, sponsored and funded by the LBS, has become an annual endeavor, helping us to encourage support of the missions of FCCOL. Almost \$3500 was raised for the Crosby Fund for Haitian Education. Also encouraging mission support, the blanket drive for Church World Services was once again, due to the efforts of Hildegard Rennhard, a success this past year.

The White Elephant Sale and the Elephant in Winter sale had a net profit of over \$80,000 in 2019. A total LBS budget of \$93,850 was drawn up and approved for 2020, \$76,900 of which is designated to LBS mission commitments. In addition to the budgeted commitments for 2019, the LBS also provided financial assistance, when requested, to a number of individuals and groups. Rent was paid to help to give Malik and Zahida time to regain their footing after their business was robbed, money was donated to assist in financing the publication of Carolyn Wakeman's book "Forgotten Voices", mortgage payments were made so that the Torres family could regain their footing after a health issue caused a financial strain, a donation was made to the Church Preservation Maintenance Fund on behalf of the Climate Change Task Force to be used to replace windows in the parsonage with energy efficient models, and money was given when requested by Tribal Crafts, the TOL Educational Fund, and individuals needing postage to mail clothing to Green Grass. When you include the many organizations supported by the hours of work and the varied skills of The Ladies Who Stitch, it is easily seen that throughout 2019, the LBS continued to use their time and their talents to demonstrate generosity in support of the church's broad mission efforts.

In 2019, we saw the departure of two board members, Ken Cavanaugh and Sissy Stinson. We also welcomed two new board members, Mary Tomassetti and Rick Strickhart.
