MINUTES OF THE ANNUAL MEETING FIRST CONGREGATIONAL CHURCH OF OLD LYME SUNDAY, JANUARY 31, 2021

Meeting conducted virtually via Zoom call

The meeting was called to order at 12:02 PM by Dan Renn, Chair of the Board of Trustees. This was followed by the Invocation, given by Reverend Laura Fitzpatrick-Nager.

Gregory Hack, the Assistant Church Clerk, made the Call to the Annual Meeting, stating that the purpose of the meeting is as follows:

- To receive the reports of the ministers, boards and committees, and the church officers for the year 2020
- To approve the church budget for the year 2021
- To approve continuation of officers and board members for one year as announced and amended by the exigency committee for the coming year
- To conduct such old and new business as shall properly come before the Congregation

Greg Hack acknowledged the presence of a quorum of at least 40 church members. At the start of the meeting, 57 devices were logged on to the Zoom call. As many as 73 were logged on at one time midway through the meeting.

A motion was made to waive the reading of the minutes from the 2020 Annual Meeting, as the minutes were printed in the Annual Report. The motion passed, and the minutes of the 2020 Annual Meeting were approved.

Individual reports were then presented. All those offering reports referred to the printed reports that appear in the 2020 Annual Report.

Steve Jungkeit, Senior Minister: Steve began by reading a stanza from "How Firm a Foundation". He asked us to think back to March 13 of 2020, and how things have changed since then. So many questions related to church services and other activities. He read from Paul, noting that we have not been separated from that love in many ways:

- phone calls the church is making, and those received
- church staff, who miraculously adapted
- how folks have been present for virtual services
- racial injustice marches
- · outdoor gatherings in back of church
- Zoom Sunday school and outdoor sessions
- · Love in time of corona
- · Successful financial appeal at year's end

Steve invoked the image of Jonathan Edwards held by God above the abyss.....we are kept from falling by tiny threads of support.....we can be a thread that holds the community together. God's love shown in these ways. Steve is so very grateful to all. Steve also asks us all to stay vigilant during the next 6-8 weeks, as he feels that it will be crucial to our well-being...text him when you have been vaccinated!

Laura Fitzpatrick-Nager, Senior Associate Minister: Laura echoed Steve's remarks. She showed a one-minute video of outdoor church service from November, with children singing and acting out "What A Wonderful World". Laura gave thanks for all aspects of assistance with the efforts of the church over the past year. She read from a poem by Gwendolyn Brooks --- we are each other's harvest, business, and magnitude. She gave many thanks to number of specific individuals for their efforts.

Carleen Gerber, Associate Minister: Most of her time is spent with pastoral and mission work. Her theme words are amazement and humility......and summarized her efforts re calls to church members, other pastoral work, and noted that missions work has continued strongly even during this trying time.

• Joanie May, Church Clerk: A small number of new members this year due to the pandemic. Church membership is down by 32, mostly due to change to inactive status. This year has seen few weddings and baptisms.

- Mark Bond, Deacons: Mark spoke about the ongoing efforts of deacons and callers. The church is one of 6 co-sponsors of a declaration re a just peace for Israel and Palestine. The Deacons hosted outdoor events and many other activities.
- Stewardship: Sandy Long standing in for Mary Kate Cox, who moved out of our area. John Kiker has done
 an enormous amount of work to assist. As of today, 89% have maintained or increased their pledge.
 Others who have yet to renew will hear from Stewardship soon.
- Youth education: Cari Blanchard spoke about prayer bundles, outdoor events when possible, and was grateful for the ability to pivot during this unique year. Many activities are highlighted in her report.
- Adult Education: Laura Fitzpatrick Nager did a quick summary for Dave Roberts. Adult Ed has done 3 Zoom Adult Forums thus far, and other forums are planned
- Board of Missions, Susan Beeman: She is honored to serve as chair, and is very thankful in light of the fiscal events of the past year. Assessed areas of greatest need, as summarized in annual report.
- Immigration: Lina Tuck. The committee started in 2017, and has slowly gathered folks interested this mission work. Lina is grateful that the Biden administration will be more favorable to this work....working towards immigration reform
- South Lyme Chapel: this has been a quiet year
- Ladies Benevolent Society: Sandy Long spoke for Jane Marolda. The White Elephant Sale was canceled for first time in 84 years (usually raises \$80K). Ladies Who Stitch raised \$4,000.
- Dan Renn, Chair of Trustees: Dan thanked the communication committee among others, and he thanked church staff for their plunge into the digital world in 2020.

Treasurers report, Bob McCracken: In this unique year, the church knew that some folks were struggling financially, and the church was looking at a \$100k deficit. The church did receive a PPP loan of \$102,000. In December, the loan was forgiven, the church received \$32K in additional gifts, and 99% of pledges were honored. Thus the church could keep its commitment to repay the endowment, as well as to benevolences and missions. Revenues received ultimately ended up above budget, and the 2020 budget ended up balanced.

2021 budget discussion: The year 2020 ultimately turned out well, so the budget process is a bit clearer. The budget calls for keeping compensation for all ministers and staff at the current levels. A reduction in major maintenance levels is included. A contribution of approximately \$60k from special reserves fund has helped to shore up budgetary shortfalls. This fund has been funded by a number of "angels" from the congregation. The 2021 budget as proposed includes \$826k of revenues and expenses, and a balanced budget. This compares with \$831k budgeted for 2020. We are extremely fortunate to be in such a strong financial position, as this is uncommon in other churches. Bob gave thanks to all of the church office team, including Joanie May, Bill Slivinski, Mary Tomassetti, along with Odile, Mark, and Terry.

The budget was approved on a unanimous vote.

- Simon Holt spoke about music activities he reviewed his plans and the hope of getting more live performances in the year to come
- Lisa Doggart gave a brief report of JPF and SPF activities.

The slate of officers and board members was proposed, reflecting that all would continue for one year, with a few exceptions as noted in the Annual Report. The slate was approved.

Deacon Emeritus -- Mark Bond proposed Lina Tuck, chair of the immigration committee, as Deacon Emeritus. Mark gave a lovely summary and testimonial re Lina's excellent work. The nomination was approved.

No old or new business was presented

Steve then gave the benediction, noting what a privilege it is to be a part of this place. He reiterated thoughts from How Firm a Foundation.....and asked us all to stay vigilant!!!

The meeting adjourned at 1:27 pm

SENIOR MINISTER'S ANNUAL REPORT

"This strange and awful time was the happiest of my life."
-Station Eleven

Station Eleven may not be the pandemic distraction that most of us think we want. Based on a 2014 novel from Emily St. John Mandel, Station Eleven is a recent television series depicting the world after a virus far worse than Covid has eliminated much of the world's population (I know, I initially didn't want to go there either!). The show follows a troupe of actors who circle Lake Michigan every year, performing Shakespeare for encampments of survivors. It wound up drawing me in because of its insistence that precarity and disaster can somehow be redeemed by immersion within a transcendent aesthetic experience — or if not redeemed, then soothed, or if not soothed, then somehow deepened. It's a story that gets to the core of what it is to pass through a terrible historical epoch, positing that in some mysterious way, moments of surpassing beauty can somehow coexist within moments of sorrow and struggle. That insight is given expression by a character undergoing a months long quarantine with two other people. Toward the end of their time together, he speaks the words with which I began. In so doing, he suggests that even against the backdrop of a world falling apart, he found meaning and connection during that disintegration in ways he never previously had. A kernel of goodness is found even in the wreckage of the world.

It's a truth of which people of faith have long been aware, found most visibly in the symbol of the cross. The cross is nothing short of a disaster, but it is also an event in which Christians have sensed the hidden presence of God, even in the depths of the disaster, insisting that all is not lost, and that there is a beauty and goodness within the world that remains, despite it all. That symbol is meant to disclose a pattern for those who know how to read and understand such signs, for hidden in the wreckage there exists a fleeting form of beauty and hope that somehow gives us the courage to endure.

I share all of that because 2021 has been a year of disasters. Which is to say, the world is undergoing a version of the cross. As of this writing, nearly 840,000 Americans have died of Covid. Nearly 5.5 million people around the world have died from the virus. Our lives have been disrupted in ways that were unimaginable to most of us two years ago, and the year has seen us all whipsawed between unrestrained optimism (remember the first stages of the vaccine rollout?) and a sinking resignation to still further waves of disruption. Some among us have lost people close to us. Others of us have spent the year making tentative plans, and then shifting them based on the best wisdom available at the moment. Still others of us have spent the year dodging the virus as best we can, while still trying to maintain a degree of normality in our lives. Added to all of it is an eerie foreboding about the level of reactionary behaviors sweeping the country — the doubling down on a lie concerning election fraud, the spread of misinformation about vaccines and science in general, and a willingness to traffic in unhinged conspiracy theories, to name but a few such behaviors — and the contours of the disaster become more steadily visible. On top of it all, a series of climate catastrophes continues to reveal the extent of the challenges before us. It's all of it taken a toll on us, though each in our different ways. Perhaps the greatest tragedy of all is the way we've each been forced to shoulder the cross of these times in isolation from one another.

As a faith community, we've done our very best to respond faithfully to those challenges. But it hasn't been easy. We spent the winter months isolated at home while we livestreamed our services. Our Sunday School met online, and our music ministry was largely reduced to solo performances that could be pre-recorded. Our ability to travel to visit our partners in South Dakota, Palestine, and Haiti was curtailed, and so was their ability to visit us. In the early part of this year, our staff worked remotely, and our boards and committees did the same, though in some cases, there wasn't much to meet about in the first place. For a second year in a row, our White Elephant Sale was suspended, and many of the other outlets for volunteering were limited. Potlucks, fellowship hours, new member luncheons, and holiday gatherings didn't, for the most part, take place. With some notable exceptions, funerals didn't happen, nor, for the most part, did weddings. The same goes for baptisms – though we did sneak a few in here and there.

But for all that couldn't happen, here's what did happen. We produced a seven week travelogue chronicling the history of enslavement and resistance in Southern New England. We invited many new guest musicians to contribute to our weekly worship, and we forged new friendships with lots of individuals living in New London and Norwich that we hadn't known before, many of whom shared in our worship services. We saw

the installation of Witness Stones up and down Lyme Street, and partnered with the schools, the library and the Florence Griswold Museum to make it happen. We conducted services outdoors when the weather got warm enough (Easter was the first of the season), and our handbell choir even managed to play during those outdoor services. When it seemed safe to do so, we moved back indoors for our first service together in the Meetinghouse in June. We received more than twenty new members in late spring, and when autumn rolled back around, we welcomed children and families back that we hadn't seen in a long time. The Ladies Who Stitch continued to gather, both inside and outside. Our trustees and mission boards have diligently distributed more than \$70,000 to organizations and mission partners who needed the funds, badly. We supported the Green Grass community with care packages and with other forms of assistance, while we've also kept up our support of those in Haiti and Palestine. A team of callers has continued to reach out to those on our membership list to keep the community connected as best we can. We've started a monthly Habitat for Humanity Day, where some of us help to construct homes in the city of Norwich, a practice that we hope, in time, will lead to a similar project in Old Lyme. In early October, after months of preparation, we welcomed a family fleeing the chaos of Afghanistan into our community. In late October, we had our Rhythm of the Saints weekend, with a visit from Dr. Michael White and his jazz ensemble, and we screened Jason Berry's extraordinary film City of a Million Dreams for our community. At Christmas, we shifted yet again, moving our 5:00 family service outdoors, even as we conducted two more services indoors, to a diminished but hearty gathering of people. Through it all, the financial generosity of our members and friends has been extraordinary as well, which has allowed us to finish the year well. In sum, while our capacities have been limited by these strange and awful times, it's amazing what we've managed to do in the midst of it all.

For me, the single event that best defined the year occurred on October 31st, during the morning worship service of our Rhythm of the Saints weekend. The Meetinghouse was as full as it had been for more than a year and half, and Dr. Michael White and his band brought the house down that Sunday. After some prelude music, the band kicked into an original song that Michael wrote in the months after Hurricane Katrina. The city of New Orleans had been hollowed out, and Michael lost everything he owned – a collection of musical instruments, thousands of books and recordings, everything. During that time he was given space at a retreat center for artists to put his life back together, and he experienced a flurry of creative activity, even within the wreckage of his life. He ended up writing a song called "Sunday Morning," a song about a Spirit that binds and encourages, a Spirit that uplifts and strengthens whenever people come together. The joy of Sunday Morning, and the Spirit present in such gatherings, was what he needed to recall in that painful time. Michael and his band opened with that song on Sunday October 31st, and the song reached into another disaster and provided a sense of uplift that we all needed by then. It was Michael's own entry into the theology of the cross, in which a sense of unmitigated joy and assurance lived even within a tumultuous present. "Come together, Sunday morning," the vocalist Gregg Stafford sang, words that spoke into our moment as we find and refind each other after a difficult period. It's a song that, in that moment, seemed to be given specifically to us.

Who can say how we'll look back on this year ten or twenty years from now. Perhaps this year was strange and awful, and nothing more. Perhaps. But I suspect for many of us, hindsight will create a mixture, where the strange and the awful gave way to simultaneous moments of happiness. I believe that happiness consists of the fact that through it all, we found one another, we supported one another, and we helped each other through the worst of it. As we enter another uncertain year, one that will present its own set of challenges, let us be patient with the times. Let us be patient with what the times are doing to us, and within us. Because it's frequently the case that what seems troublesome now winds up yielding unexpected gifts and spiritual resources somewhere farther down the line.

It's been a challenging year, but I'm so proud of how this community has responded to these strange and awful times. I'm grateful to walk through these stations of the cross with each of you.

Dear Friends,

We've turned the page on the calendar again! In this season of epiphany and appreciation, it is timely that I add my gratitude for our church and each and every one of you! Sitting in our meetinghouse this past Sunday and listening to the choir sing with such spirit and grace (even though masked), I was reminded once again of the necessary and reciprocal gift that is our FCCOL community of faith. Even though Omicron has quieted (ramrodded?) our plans for many in-person activities and events this January, your presence and support continues to be deeply valued!

This past year has brought continued challenges and renewed creative energy with our Sunday School and PF team as we've worked to re-engage youth and families. Our Director of Children and Youth Education, Lisa Doggart, and Sunday School teacher, Mary Bradford have been indefatigable in their efforts and sharing of their talents. Together, we've found creative and sustaining ways to design and implement a renewed program meeting outside and in-person for Sunday School. For this academic year we are reflecting on the message from Jesus in John's gospel: "I call you friends." (Jn 15:15) and the ways we can imagine and enact a world of friendship, equality and justice. I'm deeply appreciative of the efforts of our Board of Youth Education (BYE), and our dynamic teachers and families who comprise God's Neighborhood. Two of our Sunday School teachers are college-bound students doing a Gap Year with us and we are so grateful to them (Alex Pinkowsih and Riley Fruth). Service opportunities with our Middle/High School and Confirmation Students have included clothing drives, work at the NL Community Meal Center and a Breakfast Run to NYC and attending the Broadway show, To Kill a Mockingbird. Our PF program has also benefited from guests like Kevin Booker and others who have guided our learning and discussion around justice and the journey of faith.

Our Christmas Pageant this year reached a new milestone of joy. We are deeply grateful to the rewrites, direction and creativity of FCCOL parents, Gavin Lodge and Todd Ellison, who added fun and professionalism to our storytelling. Our cast of children and youth was incredible, too!

Likewise, it has been sustaining to collaborate on adult programming to support the spiritual life, formation and care of our congregation. From our FCCOL book clubs (thank you Martha Beaudoin for your ongoing coordination!), monthly Grief group meetings (thank you for co-facilitator, Mary McGannon Kohlman), summer writing retreat, Walking group, and Writing at the Well biweekly group. Thanks to Rev. Becky Crosby, our Thursday Bible Study sessions continue to be ever-popular. Sessions are held September to May and Becky just reached the milestone of her 14th year leading them! I continue to provide monthly Bible Study at Essex Meadows.

Adult Education on Sundays is now planned on a monthly basis after the 10:00 am church service. Throughout this second strange year of pandemic, our church has also offered a variety of Special services including the Gathering of the Saints Community remembrance service and New Orleans Jazz weekend with Dr. Michael White and his band.

One major highlight of this year was the Witness Stones project. Our church collaborated with other founding community partners, the Phoebe Griffin Noyes Library, Florence Griswold Museum and Lyme-Old Lyme Public Schools to engage in this endeavor of relearning and reckoning with our local history as inspired by the Witness Stones, Inc. project in Guilford, CT. It's been an honor to work closely with the Witness Stones team under the leadership of our Chair and historian, Carolyn Wakeman. For our first year (2021), we were able to install 14 Witness Stones along Lyme Street to commemorate the lives of individuals once enslaved in Old Lyme. A community celebration was held on June 4th, 2021 on the grounds of our town library. We also partnered with four distinguished Witness Stones Poets (Marilyn Nelson, Antoinette Brim-Bell, Kate Rushin, and Rhonda Ward) who wrote poems based on the lives of the persons being memorialized. I submitted a racial equity grant on behalf of our church from the Health Improvement Collaborative of Southeastern CT to assist with the remuneration of the poets. Further memorial plaques will be installed in the coming year. See www.witnessstonesoldlyme.org for more information and resources.

In addition, with the leadership of our Immigration Chair, Lina Tuck, I've appreciated the on-going opportunities to support our undocumented neighbors through accompaniment to ICE visits, etc. Our church and community volunteers continue to be invaluable in this justice work. See the report of our Immigration Committee. I'm also serving as Moderator of the Executive Committee of the Middlesex region of the Southern New England Conference of the UCC. Beloved church member, Michael Long, who passed away this fall, was in this position formerly and we continue to miss him and all the ways he contributed to our community.

Thanks to our devoted Deacons, Trustees and other church leaders, we've worked together to continue congregational support and connection with one another. Your efforts are deeply appreciated as we continue to navigate these challenging times.

Thanks to Eunice Taylor and other talented knitters and handcrafters of the Ladies Who Stitch, who continue to create beautiful handcrafts, support the LBS and keep this circle of community growing for the benefit of our whole church. Thank you! Likewise, it's been inspiring to observe the Saturday morning food pantry, SSKP, under the professionalism and warmth of Audrey Brainard and volunteers. The weekly numbers of guests rose during the pandemic and SSKP and your generosity is meeting the need. I'm very thankful, too, for our FCCOL Diaper Bank under the direction of Karen Stigliano, Dale Bernardoni, Jody Belluzzi, Anita Allen, and our PF volunteers which serves about 50 families in our area.

Deep gratitude to Steve, Carleen and our whole staff- Bob McCracken, Simon Holt, Odile Brennan, Mary Tomassetti, Joanie May, Mark Testori, Lisa Doggart, John Kiker, and Bill Slivinski. We carry and support each other and that brings great joy in the midst of it all.

ASSOCIATE MINISTER'S ANNUAL REPORT

It has been yet another year of unrelenting challenges. Our hopes for a definitive and expeditious end to this virus gave way over time to a reluctant realization that we are now coping with a whole new reality in ministry.

We have continued to try to maintain contact by phone with as many church members and friends as possible, enlisting the help of the Deacons, Trustees, choir members, and a few willing volunteers. The dilemma we face is in knowing how to phone or email people successfully. Some of our parishioners have given up their land lines (driven by the fact that we all receive so many unwanted calls) and we don't have access to a cell phone number. So while none of us here at the church want to add to the abundance of unwanted communications, we surely would like to know how to contact our friends and members when we need to. Please, if you're willing, update the office with the information of how best to reach you.

The work of missions has continued to be a focus for me. Under the leadership of Susan Beeman, the members of our Board of Missions dispersed all \$72,000 of its funds in this past year. We worked with partner agencies in New London to learn of their needs, and we've offered as much support as we could muster. Cathy Zall of Homeless Hospitality, and Teri O'Rourke of Habitat of Eastern Ct. met with us on zoom to give us specifics of their work, and we were able to increase funding to them at this critical time. We also substantially increased funding to FRESH New London for its emergency food outreach during the first part of 2021.

Julie Kuja, who chairs our New London Soup Kitchen team, has worked hard to maintain our commitment to serving monthly meals in New London. Charlie Hosley, Cathy Gentry and Grace DeGrooth are invaluable to that team. Each board of the church helps in preparing those meals, which serve over a hundred guests each month.

Our partnership with the Shoreline Soup Kitchens and Food Pantries has remained strong, under the able leadership of Audrey Brainerd and her pared-down number of dedicated volunteers. There are between 50 and 80 families receiving groceries every Saturday morning!

Karen Stigliano and Dale Bernardoni have continued to expand our ministry of free diapers for families in need. And the need has grown over this past year.

So, in summary, there are scores of volunteers at work, even in these challenging times, to meet the outreach and mission needs of this Covid era. Those of us who work in our church's many outreach projects are grateful for the faithful and generous support of the members of this congregation. Their generosity is what makes all our outreach possible.

Steve and Laura and I have tried to meet in person with church folks over this past year when and where it's been possible (sometimes on porches all bundled up against the cold!) But it is sometimes hard to feel like pastoral ministry is adequate when home visits, and hospital and nursing home visits, are so curtailed, and when we can't "see peoples' faces" in weekly worship. Please call any one of us if a conversation or a visit would be helpful to you for any reason, and we'll always try to make that happen.

I am grateful to Steve and Laura for the companionship we share. It is hard to imagine being able to carry out the prophetic and pastoral work of church ministry without a team that can imagine and dream together of a better, safer, more peaceful and equitable world.

I hope I have ministered to all of you with as much grace and love as you have extended to me and my family for lo these 45 past years.

Following the lead of the First Congregational Church, we planned a "Soup Night" with entertainment to encourage the public to visit the chapel and possibly join us for a service. We were actively seeking to grow our membership. This event had to be cancelled due to the onset of the pandemic, and our doors were closed for live services between March 2020 and early October 2021. During this time, we presented a service on Zoom which was attended by approximately 7–8 folks every Sunday. We offered the service at 10 AM, rather than the 9 AM time of our live services. In addition to our regular members, a family from Massachusetts attended as well—they were children of former members and decided to join us during the pandemic for a safe place to worship. Our Minister, Becky Francisco, created Sunday services which were engaging and supportive during a time of fear of the pandemic. During our online Zoom Sunday services, we began discussing the weekly scriptures, and participated in a Bible study of sorts. The members enjoyed the format and looked forward to the discussions regarding scripture.

We returned for live services in October 2021, changed our time to 10 AM, to make it easier for our aging population to attend. We moved our pews into a slanted position to encourage dialog, and continued with the scripture discussion which was begun during our Zoom worship format. We have been attempting to grow our membership through our Facebook page and links with the People of Old Lyme on Facebook, but we have had very few new attendees, and still average about 7–8 members at a Sunday service. Proceeds received from a bequest by a former member, Helen May Hill, have helped us to remain afloat during this time of reduced attendance. We feel fortunate to offer such a unique service, and wish that we could attract new members who would enjoy worshiping in a small, 120–year–old chapel with a special history and role in the Old Lyme community.

REFUGEE RESETTLEMENT

2021 proved to be an active year for the Refugee Resettlement Committee. Formed in 2015 as a response to the Syrian Refugee crisis, the committee is composed of members of FCCOL, Christ the King, and St. Ann's churches, as well as people within our community who simply wish to help. Since its inception, the work of the committee has allowed for the resettlement of a Syrian family (the Hamous), a family fleeing the devastation of Hurricane Maria in Puerto Rico (the Colons), a family fleeing violence in the Democratic Republic of Congo (the Kazadis) and a family fleeing from Iraq (the al-Khafaji family). In addition, the purchase of a house by FCCOL to be used for refugee resettlement in perpetuity has enabled our community to continue welcoming people from all around the world who are in need of a new beginning.

In 2021, the family occupying the Rogers Lake House was able to find permanent housing in the area, thanks to our friends at Hope Partnership. That proved fortuitous, for as the withdrawal from Afghanistan devolved into chaos, a whole new refugee crisis was created. In late August, we witnessed flight after flight hastily departing from the Kabul airport, each of them packed with Afghanis fleeing the chaos. With that in mind, the FCCOL property committee began to get the house ready for new occupants, while the Refugee Committee began to gather resources in order to be ready to welcome a new family. And then the waiting began.

On the evening of October 16th, a small group went to New Haven to meet the Popal family for the first time. They are seven: Hayatullah and Bibi (the father and mother) along with their children Esmatullah, Enayatullah, Reyhana, Hidayatullah, and Sola. The latter was three weeks old when they arrived in New Haven, meaning that Bibi had departed Afghanistan when she was nearly ready to give birth. Sola was born on an army base in Virginia while the family awaited their resettlement plans.

Since that time the children have started school and the parents are taking English classes. There have been many medical appointments, and lots of behind the scenes work to get things like social security numbers, health care, and other forms of assistance. There have been excursions in order to help acquaint the family with the area, and they have been connected with other refugee families in Connecticut. It's a long and painful process to relocate in such a way, but thanks to the work of the three faith communities and a whole host of dedicated volunteers, the Popals feel welcomed and loved in Old Lyme.

IMMIGRANT ASSISTANCE COMMITTEES

Mission Statement

The First Congregational Church of Old Lyme is a community of faith who cares about the world we live in, whether it is right outside our door or half a world away.

During this grave immigration crisis, we believe in strong partnerships within our community that foster trust and hope to those in fear of deportation. By offering sanctuary, education and financial assistance for legal counsel, we offer grace and hope to families in need, working together through our acceptance of all that we are, a land of immigrants. The Immigrant Assistance Committee was formed in March of 2017 at the request of the FCCOL ministerial staff and with the approval of the FCCOL Board of Deacons.

This Committee is a responsive committee that forms into action as requests arise. Our mode of communication is primarily through email updates and meetings are scheduled on an as needed basis. Currently, we are continuing to offer general support for regular asylum seekers through accompaniment to ICE appointments and referrals/advocacy as needed.

Accomplishments for 2021

During this time of Covid-19, the Immigration Committee has continued to help families in threat of deportation. While our footprint to assist new families was curtailed by the pandemic, we have continued to assist those families within our network. We will be working with local and national immigration advocates to make our voices heard.

We continue to make an impact one family at a time by assisting families who are in threat of deportation. Presently, current cases include: supporting Malik, Zahida and Roniya by accompanying to ICE visits, making sure they have legal representation or assist with referrals as well as, the Torres family in addition to other undocumented families. We were also successful in assisting a local asylum seeker from El Salvador by writing letters of support and accompanying her to a court hearing in NYC last spring. She and her child received permanent status.

Overall, we continue to work with our community partnerships, assist families in deportation crisis and provide a financial mode of assistance through church and community wide donations. The Immigration Assistance Committee ends the 2021 year with a balance of approximately \$5,000.00. We will continue to provide some financial assistance to asylum seekers as needs arise.

In the coming year, the Committee will continue to support our beloved families through accompaniment. We will continue to find ways to provide information on immigrant rights to our wider community. While we are very disappointed that no progress has been made on the Federal level to offer Immigration reform, we will work on initiatives to contact and lobby our congressional leaders to help provide a legal pathway to permanent residency and citizenship.

FCCOL is deeply grateful to our former Chair of Immigration, Lina Tuck, who has steadfastly provided extraordinary leadership for the past five years. We wish Lina well as she explores other endeavors.

TREASURER'S REPORT - YEAR-END 2021

The year 2021 continued to be a challenge to church life as we dealt with implications and limitations of the Covid19 pandemic. However, financial support by our members and friends continued strong, and we were able to meet all of our obligations and finish the year with our income and expenses balanced.

We were further blessed by receiving the second PPP Loan from the government stimulus program of \$116,650. The loan was subsequently forgiven and this became a positive equity addition to our balance sheet.

Total income received was \$831,667 or slightly over budget of \$826,274 by \$5,393. Expenses incurred were also slightly over budget, but only by the same amount so the bottom line was balanced. See the summary page 17.

On the revenue side (detail on page 18) current pledge income (#040000) continued to decline slightly from previous years, but this was offset by generous contributions of the next four-line items. Total Pledges and Offerings were under budget by approximately \$29,000. However, this was due to not needing the "Special Gifts" budget, funds provided anonymously to assist if necessary. The Pledges and Offerings shortfall was compensated for by "Other Income" items, most notably by the provision of \$19,113 from our PPP#2 forgiven loan proceeds.

On the expense side there were no significant issues. There were 2 small overages in the Music and Lay Employees categories. For Music, we brought over less than budgeted amount from the Memorial Music Fund, and Lay Employees was over due to some unbudgeted overtime and a change in the Office Manager's health benefit to being covered by the UCC program. The Benevolence budget of \$72,000 was fully expended to charities.

Pages 18 through 23 contain the account by account detail of all the revenue and expense accounts. Page 24 shows the church balance sheet as of December 31, 2021. Note that it contains a \$97,536 positive equity entry, which is the net proceeds from the PPP#2 loan of \$116,650. Pages 25 shows the balance sheet detail of the Escrow and Exchange "earmarked" funds on the balance sheet, and page 26 shows the complete accounting of the sources and uses of funds for the year 2021.



A NEW WAY TO LOOK AT OUR CHURCH'S BUDGET



This type of presentation is important and necessary for the responsible accounting of our finances on a daily basis. MISSION OUTREACH


Our Board of Missions (through the operating budget), and the Ladies Benevolent Society (through the White Elephant Sale) generously support over 75 local and international charities and missions each year. We also nurture partnerships with churches in South Africa, a Native American community in South Dakota, Koinonia Farm in Georgia, Beit Sahour in Palestine, a school in Harlem, and a foundation in Haiti.

WORSHIP

We conduct inspiring worship services every Sunday morning in our historic Meetinghouse and at the South Lyme Chapel, to which ALL are welcome. These are in addition to special services during the Christmas, Easter, Lenten and Thanksgiving seasons. Our 3 ministers deliver consistently inspiring and challenging sermons, and the services provide quality time for meditation, prayer, and the enjoyment of sacred music.

COMMUNITY OUTREACH

We are the largest site in SE Connecticut for the Shoreline Food Pantries and Soup Kitchens, distributing groceries and serving meals to at least 100 families each week. We also host the local Cub Scout Troop, Red Cross blood drives. Musical Masterworks concerts, Visiting Nurse Association activities, AA meetings, and much, much more.



CHRISTIAN EDUCATION

We have a vibrant Sunday School program called "God's Neighborhood" meeting every Sunday featuring several and "diversity Sundays" to nurture understanding of other faiths and cultures. There are active Junior and Senior High Fellowship groups, Bible study and book groups, poetry and writing groups. And the Adult Forum presentations every Sunday provide discussions of challenging issues.

Our extensive music programs enhance the worship services and lives of many participants: A 45+ person Senior Choir, a seasonal bell choir, the Children's choir, a seasonal bell choir, music sessions during "God's Neighborhood" and special concerts provide opportunities to enjoy and participate in music year-round. We are grateful for our professional Directors and Soloists for their skillful leadership of these programs.

OUR CHURCH IS INDEED A PLACE OF GRACE

PROPOSED 2022 BUDGET OVERVIEW

Preparation of the annual church budget is the responsibility of the Budget Committee of the Board of Trustees. Each year in the fall, the different boards, committees, church staff and ministers are asked by the Budget Committee for estimates of expenses for the coming year based on their plans and programs. At the same time the Budget Committee works with the church treasurer and the Board of Stewardship to estimate the church income for the following year. The final budget is then prepared as an iterative process, balancing the expense estimates with the projected income. The Board of Trustees approves the proposed budget at their January meeting, and presents this proposal to the congregation at the church annual meeting in January for congregational approval. This year our Treasurer acted as the Budget Committee. The 2022 Church budget is shown on Pages 30 through 36 of this annual report.

OVERVIEW

This year, as everyone knows, we continued to operate in the Covid Pandemic mode. Church services in the Meetinghouse resumed in person but at much reduced attendance, and many other activities of the church took place remotely via Zoom, or were postponed indefinitely. However, the financial support from our members and friends continued strong, for which we are all grateful. In addition, the church received the second PPP loan from the government that was subsequently forgiven. This added \$116,650 to the church balance sheet, allowing substantial flexibility in what we are able to accomplish financially. We needed to use \$19,000 of that amount to balance the books in 2021. However, allowed us to continue with full staff and meet our budgeted benevolence budget. This also allows us to meet some needed — and delayed — increases in our operating budget for 2022.

REVENUES

On the revenue side we are estimating income from pledges and other contributions from the congregation to remain the same as in 2021. Total Pledges and Offerings in 2022 is a reduction from the 2021 budget, since we did not need to utilize a "Special Reserves" account in 2021. The substantial increase budgeted in "Other Income" however is the addition of \$66,000 from the PPP loan proceeds, needed to fund some needed increases in budgeted expenses, explained below. Total revenues for 2022 are budgeted at \$884,643, up from \$826,274 in 2021.

EXPENSES

There are five areas of increase in budgeted expenses for 2022: (1) Increase in staff compensation of 4%, representing a "catchup" from a compensation freeze in 2021 and the significant increase in inflation. (2) An increase in the Christian Education budget representing added expenses from operating in the Covid environment, and an additional well deserved and delayed increase for the Church School/PF Fellowship leader. (3) An increase in medical insurance for the Office Manager who is now covered by the UCC program, rather than "in lieu" payments augmenting her spouse's policy. (4) In increase in the Benevolence budget from \$72,000 to \$80,000 to begin returning to historic levels. (5) An increase in the Property budget reflecting some needed but delayed improvement projects. The next summary page shows budgeted revenues of \$884,643 balanced by projected expenses of the same amount.

A property improvement note: We implemented two important ventilation and air purification projects in 2021 to make these spaces as safe as possible in the Covid environment. These were funded by the Preservation Fund which is separate from our operating finances and managed by the Endowment Committee of the Board of Trustees.

We continue to be extremely fortunate to be able to present a balanced budget in these difficult times, thanks in large measure to the high level of dedication and commitment of our members and friends, as well as assistance from the government loan forgiveness.

<u>Church Bylaws:</u> "The Board of Trustees shall supervise the procurement, custody, and care of all Church property and the management of the financial affairs of the Church with the limitation that no real property shall be bought, sold, mortgaged, leased or transferred without specific authorization by the congregation. In addition, the Board shall maintain custody of all Church funds, including funds raised or granted to any Church board, council, committee, or other Church sponsored associations. It shall be the particular responsibility of the Board of Trustees to appoint and supervise the following committees:"

ENDOWMENT

The Endowment Committee is charged with the management of all financial gifts, contributions and bequests (not specifically designated), and invests them, with the guidance of our advisors at Morgan Stanley, in a perpetual endowment fund which is separate from the church operating funds. Five percent of the value of the Endowment Fund is used each year for church operating expenses. A full report of the Fund can be found on pages **42** and **43** of this annual report.

PRESERVATION

The Preservation Fund's first gift in December 2016 initiated a campaign in 2017 to raise more funds for this separate account to help with the costs of maintaining our church buildings and property. This Fund is under the auspices of the Trustees and is managed by the Endowment Committee and our advisor, Morgan Stanley. Since that first anonymous gift of \$100,000 there have been 50+ gifts and the proceeds of an investment that brings the value at the end of 2021 to \$320,753.

PROPERTY

Our 2021 work focused on major enhancements on the ventilation within two of the major spaces within the church, along with some cosmetic upgrades throughout the campus.

The committee completed the following projects, as approved by the Trustees in 2021:

- Installation of a ventilation/heat recovery unit in Fellowship Hall. This required both structural and electrical upgrades in the kitchen area to support the new equipment. This system is tied into the existing HVAC equipment.
- New UV air scrubbers along with outside ventilation was installed into the existing heating system within the Meetinghouse. The committee is very appreciative to the many hours Dave Speirs volunteered to oversee both of these projects.
- The oil tanks in the meeting house basement were replaced along with the supply lines.
- Moe Ancil donated his time and the materials for the wonderful new sign at the corner of Lyme Street and Ferry Road. This new sign will allow the church to display messages as needed.
- Russell Fogg completely painted the interior of the Rogers Lake House between tenants this past summer.
- Wayne Walker touched up the Meetinghouse to buy us more time until the next major paint project is required.

- Tom Kratzert made some minor modifications to the Meetinghouse to help make the space a bit more friendly for wheelchairs.
- The Committee is currently evaluating the slate roof over the Meetinghouse. The roof is nearly 110 years old and is beginning to show signs of replacement.

The Property Committee and Board of Trustees would like to thank all of the tireless volunteers without whom these projects would never happen.

Finally, both the Committee and the Church community lost a great friend and supporter in Tom Kartzert this past year. Tom was tireless in completing many of the project we have undertaken over the last 15 years, including the recent Fellowship Hall ventilation project. He will be greatly missed by all.

BUDGET

Preparation of the annual church budget is the responsibility of the Budget Committee of the Board of Trustees. Each year in the fall, the different boards, committees, church staff and ministers are asked by the Budget Committee for estimates of expense for the coming year based on their plans and programs, so church budgeting is very much a bottom up process. At the same time the Budget Committee works with the church treasurer and the Board of Stewardship to estimate the church income for the following year. The final budget is then prepared as an iterative process, balancing the expenses estimates with the projected income. The Board of Trustees reviews the draft budget at its December meeting and approves the final proposed budget at its January meeting. The proposed budget is presented to the congregation at the church annual meeting for congregational approval. The 2022 Church budget is shown on pages 29 through 36 of this annual report.

The ministers and staff of the church again worked together smoothly this year, in an environment still challenging due to the ongoing pandemic.

Bob McCracken held down the fort in the church office, maintaining an in person presence in the office throughout the year. Other church employees and volunteers worked primarily from home, as have many employees in other businesses throughout the region.

This was the second full year of work for Odile in the church office. She handled her responsibilities very capably, and has become an important part of the team. Mary Tomassetti was hired to serve as Bookkeeper, and is a welcomed addition.

We all know that the ministers did a remarkable job week after week. They carried out their responsibilities and hosted Sunday services outside when the weather permitted, and virtually in the cooler months, and then finally resuming indoor services. We are all appreciative of their efforts to keep the Congregation connected, and to provide the opportunity for services complete with superb sermons and music.

As we entered the Budget season, we reviewed the current pay and benefits packages for all Church employees and independent contractors. We provided input and suggestions for the year to come. Current pay levels remain comparable to national data provided by the UCC in the annual Compensation Handbook. We have advocated for an increase for all clergy and staff after a wage freeze last year.

The final decisions re compensation will take place at the upcoming January 2022 Trustees meeting, and will go into effect following the vote at the Annual Meeting. We also reviewed the health and life insurance packages for ministers and staff. We acknowledged that health insurance costs represent a large and growing portion of personnel-related expenses.

The ministers and others are paid a set salary, with these salaries noted in the budget spreadsheet. For those employees who are paid on an hourly basis, hours for the year have been estimated, with expected

total pay listed on the budget spreadsheet.

Throughout the year, I was frequently reminded of how fortunate we are to have such a professional staff working in the Church office, under the leadership of Bob McCracken, our Church Administrator.

COMMUNICATIONS COMMITTEE 2021 SUMMARY REPORT

Overarching Focus: We continued to handle all communications on church activities via its website, Facebook page, YouTube page and Constant Contact account through the middle of July 2021 — at which point we provided training for Odile in how to handle the various communications channels and successfully handed off oversight of these communications to her. Since mid-July, we have been available on an as-needed basis to provide assistance to Odile whenever the church encountered problems with communications channels that required troubleshooting.

Emails: We created two separate email lists for Lisa Doggart to use to communicate with families and youths, and trained Lisa in the use of Constant Contact in February — at which point we handed off oversight of these communications to her. (As noted above, we trained Odile in the use of the church's Constant Contact account and turned control of email communications over to her.)

Website: We successfully launched the redesign of the church's website in January and concluded the church's contract with Good Design. (As noted above, we trained Odile in the use of the website and turned over day-to-day control of website communications to her in mid-July.)

Stewardship Campaign: We drafted the communications plan, theme and messaging for the 2022 Stewardship Campaign, then developed collateral materials that included letters to current donors, lapsed donors, new members and overdue donors, among other items.

Rhythm of the Saints Events: We provided communications support (website announcements, Facebook posts, press release, Constant Contact emails) for the "Rhythm of the Saints" weekend of events.

ENVIORNMENTAL COMMITTEE

In 2021 the committee continued its efforts to update parishioners not only about climate change and other environmental trends but also about emerging approaches, policies, and interventions. Articles in FCCOL's monthly newsletter covered these topics:

- The successes and failures of November's UN Climate Change Conference (COP26) in Glasgow
- The effect of global warming on the movement of the jet stream, which leads to intensified weather patterns, including severe droughts and catastrophic rainfall
- Personal and communal actions to combat climate change, including progressive organizing for Baby Boomers/others over 60, and campaigns to reduce subsidies for and use of fossil fuels
- Gardening practices to help the precious hummingbird, a "can-do" symbol of hope, to survive and thrive

 among these are planting bee balm, columbine, jewelweed, and other native species
- Vegetarian and vegan recipes to help reduce our consumption of meat, the production of which contributes high levels of greenhouse gas emissions
- Farming methods ("regenerative agriculture") that replace extractive techniques with those that restore organic matter to the soil, with carbon sequestration and increased productivity among the benefits
- A program known as "conservation ranching" that rotates livestock grazing, which increases pasture plant diversity and carbon sequestration, while producing healthy grass-fed beef
- Robin Wall Kimmerer's Braiding Sweetgrass: Indigenous Wisdom, Scientific Knowledge, and the Teachings of Plants, which encourages a fresh look at the world around us.

BOARD OF STEWARDSHIP

The Board of Stewardship is responsible for securing financial support for the Church and its benevolent and mission activities through annual pledges by the Church membership during our Stewardship Campaign, which in normal times accounts for about 80% of the church's annual revenue. This year, due to a diminished amount of collection plate funds on Sundays, canceled events like the White Elephant Sale, and canceled fees for building usage, Stewardship needed to raise more than ever.

The 2022 campaign to fund the 2022 Church budget began on Stewardship Sunday, September 26, 2021. Rev. Steven Jungkeit delivered a powerful Stewardship message: "He is going ahead of you. As a community of faith — a church — Jesus is always out there ahead of us, urging us to catch up. In this time of acute pandemic fatigue, when many people are losing heart and losing patience, we could all use the encouragement keep moving. Jesus is out there ahead of you...Your financial contributions enable us to be who we are, ... helping this congregation to be at the prow of the world."

A letter asking for a commitment, along with a pledge card and a descriptive page of information on "How Your Church's Financial Resources are Invested" had been mailed to 670 members and friends of the Church, so that it was received by Stewardship Sunday.

In the following four weeks, Dale Bernardoni from the Board of Trustees, Susan Beeman from the Board of Missions, Cara Cheung, a relatively new member who volunteers and whose husband Matt Muehl-Miller serves on Missions, and Rick Strickhart from the Board of Deacons and LBS each gave heartfelt and inspiring messages from the pulpit on Sundays that had a very positive effect on the campaign.

On October 25th an colorful, oversize postcard reminder was sent to all who had not yet pledged. On November 12, a short but forceful letter with a pledge card was sent to 430 who had not yet pledged. Stewardship information on the FCCOL website was revised and Stewardship messages appeared in the monthly Newsletters and weekly bulletins.

As of January 3, 2022, a total of 282 members and friends have made commitments of \$557,617. Amazingly in these Covid times, 93% of those who pledged have maintained their previous level or are new pledges or have even increased their pledge, for which we are deeply grateful.

In the coming months our Board will continue to reach out to those who have not yet responded, so that our Church can maintain its operations, benevolences, and mission activities.

Our sincere thanks go to Senior Minister Steve Jungkeit, Senior Associate Minister Laura Fitzpatrick-Nager, Associate Minister Carleen Gerber, and Treasurer Bob McCracken for their invaluable knowledge, guidance, and support. We deeply appreciate John Kiker for developing our communications, Joanie May, the best tireless volunteer, who flawlessly manages our operations, and FCCOL Office Manager, Odile Brennan, who makes our communications come to life visually.

ENDOWMENT COMMITTEE REPORT

The Endowment Committee is responsible for the management and investment of all gifts, contributions and bequests not specifically designated. Such funds are placed in a perpetual Endowment Fund. The objectives for management of the Fund are: (a) preservation and growth of the fund to ensure support of the Church if needed in times of severe economic downturn and/or for other unusual and compelling needs, and (b) to support the annual operating budget of the Church.

For the 2021 budget, the Endowment provided the Church with operating funds of \$112,474, which was 5% of the previous three-year average year-end value of the Fund, less restricted funds, in accordance with the Church's bylaws.

The Endowment portfolio maintains a long-term asset allocation objective of 70% stocks and 30% fixed income. The allocation varies around this objective as market and economic conditions evolve. In 2021, the Endowment returned 15.8%.1 The fixed income allocation of the portfolio is conservatively invested, principally with high quality, shorter-term securities. On a timely basis, we are moving more to index funds.

The value of the church Preservation fund at the end of 2021 was \$320,753. The Preservation Fund contributed \$78,300 to the HVAC church air-cleaning program.

The investment results of the Endowment in 2021, and since inception (1988) compare favorably to the Endowments targeted asset allocation index consisting of 70% stocks and 30% fixed income.

JUNIOR AND SENIOR PILGRIM FELLOWSHIP

Our Pilgrim Fellowship met each month during the fall of 2021 for service projects and discussions. Pilgrim Fellowship youth help to teach in our Sunday School and also help out at the monthly diaper bank. Each first Sunday of the month our youth gather from 4–6 p.m. for discussions, a service project and some social time. We presently have about 12 youth in our Confirmation class, one of our small groups that meets during the first Sunday afternoon.

The first meeting was held on September 12 and we met in the garden at church to introduce our ideas for the year. For the first hour, Rodney Brown led each group in a team building game while Lisa led the discussion with each group. We then carpooled to a property on Buttonball Road for a nature hike led by Evan Griswold where we viewed the site of a potential future project, building a bridge across a swampy area.

On October 3 the group met again. This time the groups met to discuss respect and to prepare for the Breakfast Run that we would take on October 16. Isaac Doggart led the group in making cookies to bring. Tom Doggart led another group in planning and designing the bridge.

On October 10, our JPF hosted a hospitality hour after the church service.

Our Breakfast Run trip was held on October 16. The group left early in the morning for New York City and served breakfast, prepared lunch and handed out toiletries and socks to friendly residents in New York City. The youth then had lunch in a local park and went to see To Kill A Mockingbird in the Shubert Theatre. The group came back to Old Lyme with a new appreciation for both our time period and for people they met and visited with during the Breakfast Run.

On the morning of October 17 some of our JPF joined in the Beach Cleanup at White Sands Beach.

During our November 7 meeting, we heard from Kevin Booker and friends who led discussions in biases and stereotyping. We discussed the role of negativity and bullying in our communities. Kevin Booker led us to connect in small groups to discuss ways to make a difference through education, social media presence and being an upstander on an individual basis.

On November 14 our SPF and JPF met during the morning to make soap dishes and soap to sell during the holiday sale on November 20 to help fund our service projects.

November 20 and 21 our youth sold baked goods, soap and soap dishes during the holiday sale. This money is important to help fund our service projects during the year.

Our SPF served at the New London Community Meal Center on November 28. About 107 hungry folks enjoyed chili, cornbread, salad, and apple crisp (made by families and the youth from a day of gleaning at Scott's Yankee Farmer).

The afternoon of December 5 we met again to get together in small groups to discuss next steps in our small group discussions. We thought about what the purpose was for each group and then each group made a plan for making a difference. For our service project portion of the night we made wreaths out of fresh greens for the ministers to deliver when they visit folks in our church community. The youth also chose names off our giving tree so that they could supply a present to a person whose family visits our food pantry. A total of 8 families were served as a result of this effort.

Our youth assisted during the December 19th Pageant and during our 5 p.m. Christmas Eve Service.

Our Pilgrim Fellowship groups are lively and enthusiastic and a pleasure to meet and work with. They are a true blessing to our community.

BOARD OF MISSIONS

In 2021, the members of the Board of Missions continued to support the social justice and mission-based goals of the congregation within budgetary allowances. The Covid pandemic remained an overarching issue in 2021 impacting our partners, our communities, and the way the board was able to meet and conduct business.

The board held five meetings in 2021; four were zoom meetings. To help members understand the needs, application of funds and the continuing impact of Covid on our partners locally, nationally, and internationally, the board reached out to partner representatives for information. We were pleased that representatives joined our zoom meetings, answered telephone interviews, and responded in writing and in person. This helped the board to target benevolences to achieve the most impact.

In 2021, 100% of the budgeted \$72,000.00 was dispersed. Approximately 61% of dispersed funds supported outreach activities including the Homeless Hospitality Center, Alliance for Living, Covenant Shelter, Fresh New London, the New London Soup Kitchen, Safe Futures, Thames River Family Programs, Martin House, the FCCOL Diaper Bank, LOL Foodshare Garden, Habitat for Humanity of SECT, hospital chaplaincies in both Middlesex and New London counties, the Ecuador Foundation Fund, Public Art For Racial Justice Education (PARJE), IRC* New York, Drs Without Borders and the Integrated Refugee & Immigrant Services.

All direct partners continued to receive financial support. Despite geopolitical and environmental disturbances which eliminated or reduced travel, the board looked for additional or alternate ways to support our partners at Tree of Life, the Crosby Fund and Green Grass. For example, when the board learned that a soup kitchen needed funding in the Artibonite Valley in Haiti, the board sent an additional \$600.00 to support this effort. Approximately 8.5% of the budget went to direct partner support. UCC support received 24.6% of funding and Mission Education Funds received 5.6% of funding.

In January of 2021, monies were rolled over from the 2020 budget year mission savings fund after the 2020 budget was finalized and before the 2021 budget was allocated. These funds were spent as part of the 2020 budget year.

*As noted on Christmas eve, In the December 12th edition of 60 minutes there was an interview of the international Rescue Committee's director for Afghanistan. In 2003, in response to the Taliban's ban on educating women, a Board of Mission's grant helped launch an underground school for girls in Herat Afghanistan. This past October, the Board once again confirmed its support for girl's education in Afghanistan with a grant of \$2000.00 to IRC.

We encourage FCCOL members to bring organizations or causes which meet the mission and goals of the church and deserve financial support to the attention of any board member.

HAITIAN OUTREACH COMMITTEE

The Haitian Outreach Committee strives to engage the congregation in the activities and work of the Crosby Fund for Haitian Education and to support initiatives that benefit the community around Deschapelles, Haiti.

Update: This past year due to Covid-19, all activities engaging the Outreach Committee and our church were either cancelled or limited. We hope to resume more activities in 2022. Ted and Becky Crosby managed one trip to Haiti in April of 2021, but since that time there has been increased political insecurity and it is not safe to return. Covid-19 is under control in Haiti. Immunizations began in the fall of 2021, but many cannot find a second vaccine. The lack of visitors to the nation and the decreased travel within the nation has helped contain the virus. The scholarship and educational programs of The Crosby Fund are doing very well thanks to their capable Haitian staff. All schools in the Artibonite area are open in Haiti and functioning normally. Food insecurity continues to be a serious problem caused by the political and economic crisis. It is estimated that 60% of the population or 6.6 million people are undernourished.

The partnership with our church continues to be a ray of hope for the Haitian people living in the region of Deschapelles. In 2021, FCCOL helped the community in the following ways:

- The Board of Missions of FCCOL supported the scholarship program of the Crosby Fund for Haitian Education with an annual gift of \$3,500. These funds pay for Haitian students from pre-k to university to go to school in Haiti. For more information about the program see the website www.crosbyfund.org
- The Partnership Co-operative shop in our church re-opened in November with a wonderful sale for Christmas in the Fellowship Hall. The sale included Haitian arts and crafts, olive oil and other goods from Palestine, Tribal Crafts, and hand-made items from the Ladies Who Stitch. Collectively, we sold almost \$15,000! Since then, we have re-opened the shop in the church and continue to sell. Through the dedication of Amy Agles in Niantic, our Haitian artists have on-line presence on Esty-<a href="https://doi.org/10.2006/journal.org/10.2006/jo
- Ladies Who Stitch made dresses, collected t-shirts, blue-jeans and underwear for the children of Haiti. A special thanks to Helen Burke, who made over 100 of these beautiful dresses. These items were shipped in January 2021 and were distributed in April 2021. Thank you to the Ladies who Stitch! Many children and families were thrilled to receive these gifts of love. Adorable pictures from this distribution were in the May newsletter.
- Food Distribution Project Learning about the problem of food insecurity in the Deschapelles area, the mission board wanted to make a gift to help alleviate the hunger. Becky Crosby learned of a group of friends in this region that have started a food pantry and distribution effort. They began with some donations from the Haitian diaspora and local people who saw the need. The mission money from FCCOL was used for the food distribution on Christmas day. Over 320 people benefitted from a bag of food that contained rice, beans, corn meal, oil, and soap. Many thanks to the Mission Board!

Eunice Taylor of Ladies Who Stitch coordinated with David Good of the Tree of Life Partnership, Becky Crosby of the Crosby Fund for Haitian Outreach, Stephanie Kenny of the Green Grass Committee and Tribal Crafts, and Lisa Doggart of Pilgrim Fellowship. A two day sale was organized and these partnerships that are supported by and so important to our FCCOL ministry were able to sell their goods and raise money and awareness for their important causes. The sale was an overwhelming success, and we are hoping to make it an annual event.

As I write this report for submission, the pandemic's new player, Omicron, has let us all know that the struggle is not yet over. Some things are better, but decisions regarding restrictions and many aspects of daily living are still being made on a day to day basis. Things are very bad in some places, and better in others. I believe most of us are grateful for where we are, and for how things are being handled in our towns and in our state. Being grateful, and being hopeful, are so very important.
